- 1. <u>Welcome</u>. Guerinot welcomed two new members to the committee, Abbie Day and Samantha Hegmann. Guerinot reminded the committee that Cara White started her term as chair of the committee.
- 2. <u>Spread Respect Forum</u>. Bergstrom informed the committee that the 2019 America East Spread Respect Forum will be held Sunday, October 20 Monday, October 21, 2019 at the University of Vermont. Bergstrom reviewed the process for student-athlete applications and reminded the committee that RSVPs are due September 18, 2019.
- 3. <u>Scholarship and staffing requirements</u>. Guerinot reminded the committee that the conference's staffing and scholarship requirements were incorporated into the conference's bylaws. Further, the Administration Group tasked the CCC and SWAs with providing feedback regarding the implementation of these minimums. The committee will provide formal feedback to the conference office by September 6, 2019, which will ultimately be presented to the Administration Group at its October meeting.

Kent State apologizes, investigates women's field hockey game cancelled for football pre-game fireworks

Kent State University President Todd Diacon has apologized for the school's decision to end a women's field hockey game headed into double-overtime to allow for fireworks before a football game on an adjacent field.

KENT, Ohio – Kent State University has launched an investigation into the handling of a double-overtime field hockey game on Saturday morning that was cut short to allow for

scoreless game headed into its second overtime "in order to accommodate pregame events for our football game on an adjacent field."

The field hockey game was ruled a no-contest.

"It was a regrettable decision, and I am truly sorry about it," Diacon wrote. "All week, I have been thinking of the visiting student-athletes who spent countless hours practicing and preparing for a tournament on our campus, and of the parents who traveled here to show their support. We can, and must, do better."

Diacon said the university's Office of Compliance, Equal Opportunity and Affirmative Action has launched an investigation into the incident, which sparked outrage on social media.

"The canceling of the field hockey match between these two teams does not reflect who we are as a university or as a welcoming community," Diacon said. "Prioritizing a swift investigation and implementing its recommendations allows us to recalibrate our actions to once again reflect our highest ideals."

Athletic Director Joel Nielsen also penned a statement apologizing to the University of Maine and Temple University on behalf of Kent's Athletic Department.

"In hindsight, a different decision should have been made to ultimately ensure the game reached its conclusion," Nielsen said. "I realize that my statement does not undo the negative impact on the student-athletes, coaches, staff and fans who deserve to see their

University of Maine Athletics Director Ken Ralph <u>said in a statement</u> that his school's players were left "confused and hurt" by Kent State's decision to call off the end of the game.

"While it is well known Kent State University had indicated back in May the field was not available after 10:30 a.m., it is also clear that there is a full executed contract authorizing a 9 a.m. start," Ralph said. "Once you allow a game to commence, you are obligated to allow the game to continue to conclusion."

Temple University Athletics Director Patrick Kraft <u>said in a statement</u> he was proud of coach Susan Ciufo, who <u>recently told reporters</u> she felt the game cancellation reflected something "deeper" than a scheduling conflict.

"It wasn't necessarily Kent versus Temple and Maine. It wasn't necessarily field hockey versus football or fireworks. This was something that we felt was deeper," Ciufo said in a video posted by the university's athletics program. "Whether this happened to a men's soccer program or not, it happened to a women's field hockey program."

The National Field Hockey Coaches Association <u>also issued a statement</u> saying KSU's decision is harmful not only to the athletes, coaches and families involved, but also to all female student-athletes.

"While we understand that the fireworks were deemed to be an important part of Kent State University's Family Weekend festivities which featured the home football contest, we cannot understand why the university would seemingly prioritize a daytime fireworks display over the completion of a Division I women's field hockey contest," the NFHCA said. "We ask those in administrative and leadership positions at Kent State University to do some soul searching and to take responsibility for the lack of judgment and poor decision-making that was displayed on September 7."
