ACTIONS TAKEN ON PROPOSALS SUBJECT TO THE OVERRIDE PROCESS

During its July 14, 2011, telephone conference, the Legislative Council reviewed its legislative decisions regarding NCAA Proposal No. 2009-100-A (Recruiting -- Tryouts -- Nonscholastic Practice or Competition and Noninstitutional Camps or Clinics -- Men's Basketball) and Proposal No. 2010-30 (Recruiting -- Telephone Calls -- Time Period for Telephone Calls -- Sports Other Than Football). The Legislative Council sustained its previous action of adopting Proposal No. 2009-100-A (which was amended and also adopted by the NCAA Division I Board of Directors) and reversed its previous action of adopting Proposal No. 2010-30.

As a result of the Legislative Council's actions, Proposal No. 2009-100-A will be subject to a membership override vote and Proposal No. 2010-30 is defeated, pending potential review by the NCAA Division I Board of Directors during its August 11 meeting.

NCAA DIVISION I LEGISLATIVE COUNCIL SUBCOMMITTEE FOR LEGISLATIVE RELIEF BLANKET WAIVER. WOMEN'S LACROSSE QUIET PERIOD 2011 IFWLA U-19 WORLD CUP. (JUNE 10, 2011).

The NCAA Division I Legislative Council Subcommittee for Legislative Relief issued a blanket waiver to permit Division I women's lacrosse coaches to attend the <u>August 4-13, 2011</u>, International Federation of Women's Lacrosse Association (IFWLA) U-19 World Cup. The Division I women's lacrosse recruiting calendar designates August 1-31 as a quiet period. In issuing this waiver, the subcommittee noted that the Intercollegiate Women's Lacrosse Coaches Association (IWLCA) surveyed its coaches and the vast majority were in favor of attending this event due to the elite nature of the event and the fact that the event takes place only once every four years.

Further, Division I coaches may not engage in off-campus contacts with prospective student-athletes while attending the 2011 U-19 World Cup event (i.e., coaches are not permitted to designate August discretionary contacts to engage in in-person, off-campus contacts with prospective student-athletes while attending the 2011 IFWLA U-19 World Cup Event). Finally, the subcommittee noted that this is a one-time waiver, the IWLCA must work with a conference office to propose new legislation regarding the IFWLA U-19 World Cup, as future waivers will be denied.

- *Seven contact days selected at the discretion of the institution and designated in writing in the office of the director of athletics. On the designated days, an institution's coaches are not restricted in the number of prospects contacted in a single day.
- **August 4-13 Div. 1 Coaches will be permitted to attend IFWLA U-19 World Cup. May NOT engage in off-campus contacts with PSA while attending.

MIDYEAR REPLACEMENT -- REPLACED STUDENT-ATHLETE REMAINS ENROLLED AND CONTINUES TO RECEIVE ATHLETICS AID (I) (JULY I, 2011)

In Women's Volleyball and Football, the academic and membership affairs staff confirmed that a counter who is replaced at midyear pursuant to the midyear replacement legislation may remain enrolled at the same institution as a graduate student (or as an undergraduate student seeking a second baccalaureate degree) and may continue to receive athletically related financial aid.

STAFF INTERPRETATION: CRITERIA FOR DETERMINING
SEASONS OF COMPETITION FOR PROSPECTIVE STUDENTATHLETES PRESENTING SECONDARY-SCHOOL CREDENTIALS
FROM COUNTRIES WITH MULTIPLE TIERS OF SECONDARYSCHOOL EDUCATION WHO SUBSEQUENTLY COMPLETE AN
ADDITIONAL YEAR OR YEARS OF SECONDARY SCHOOL IN
ANOTHER COUNTRY (I) (JULY 7, 2011)

The academic and membership affairs staff determined that a prospective student-athlete from a country with multiple tiers of secondary education, who successfully completes the initial tier of secondary education in his or her home country [e.g., General Certificate of Secondary Education in the United Kingdom] within the timeframe prescribed for completion by the country's ministry of education, and subsequently graduates from a secondary school in another country, including the United States, shall be permitted to advance his or her graduation date by one year.

The countries for which this policy applies are all multitiered leaving exam countries. This includes, but is not limited to, the United Kingdom; the University of Cambridge international exam program; New Zealand; Quebec, Canada; Scotland; the Caribbean exam countries and British patterned Africa.

REMINDER: LAST DAY OF NLI SIGNING PERIOD IS AUGUST I, FOR ALL SPORTS EXCEPT FOOTBALL AND BASKETBALL

The last date to sign a prospect to an NLI for the 2011-2012 academic year is Monday, August 1, 2011. Please note that if a prospective student-athlete signs an NLI on the final signing date (August 1) then in order to meet the 21 day submission deadline the NLI must be received by the CAA via fax or email/scan on or before Monday, August 22, 2011. Any NLI's submitted to the CAA after August 22, will be considered invalid.
