AWARDS, BENEFITS AND EXPENSES -- BENEFITS, GIFTS AND SERVICES -- PERMISSIBLE -- RESEARCH STUDIES INVOLVING ONLY STUDENT-ATHLETES -- INSTITUTION-BASED RESEARCH STUDIES

Proposal 2009-4 became effective on April 30, 2009. Reference Bylaws 16.11.1.11.1 and 16.11.1.11.2 in the 2009-2010 NCAA Division I Manual.

Intent: To specify that a studentathlete may receive compensation from an institution for partici-

pating in a research study involving only student-athletes, provided the study is initiated and conducted by a faculty member at a member institution and the study and compensation arrangements are approved by the institutional review board of the faculty member's institution consistent with policies applicable to other institution-based research studies.

Rationale: It has become common for institutions to use student-athletes in studies specifically related to the conditions under which student-athletes participate in an attempt to gain more knowledge about the characteristics of athletics participation. Current legislation permits student-athletes to receive standard compensation for NCAA research studies, provided the compensation is consistent with compensation offered in studies involving non-athlete

populations. Further, it is permissible for student-athletes to receive compensation for participation in studies that involve both student-athletes and non-athletes, provided they receive the same compensation. With the oversight provided by institutional review boards, which set the compensation independent of the researchers, it is not necessary to limit the ability to compensate student-athletes to NCAA studies only. This proposal is being recommended as noncontroversial legislation, inasmuch as broader consultation and debate are unlikely to improve the proposal in any substantial way, significant disagreement or alternative points of view will not be generated and there does not appear to be a significant impact on existing or proposed legislation.

REMINDER- CAA NONQUALIFER RULE

CAA Article IV, Fundamental Principles 4.01-C states: Since the median of each institution's freshman class academic profile far exceeds the NCAA minimum standards for freshman eligibility, if a recruited non qualifier enrolls at a member institution directly from high school, the individual will not be eligible to represent the institution in a CAA sport. The institution, through its chief executive officer, may appeal in instances of special circumstances for relief from this legislation.

NEW PROPOSAL CURRENTLY IN EFFECT BYLAW 16.5.2-(G)(H)

Proposal 2008-43 became effective on August 1, 2009.

Bylaw 16.5.2 Identifies housing and meal benefits incidental to a student's participation in intercollegiate athletics that may be financed by the institution and now permits:

(g) **Nutritional Supplements.** An institution may provide permissible nutritional supplements to a student-athlete for the purpose of providing additional calories and electrolytes. Permissible nutritional supplements do not contain any NCAA banned substances and are identified according to the following classes: Carbohydrate/electrolyte drinks, energy bars, carbohydrate

boosters and vitamins and minerals.

(h) Fruit, Nuts and Bagels. An institution may provide fruit, nuts and bagels to a studentathlete at any time.

CAA INTRACONFERENCE TRANSFER RULE (APPLIES TO ALL CAA SPORTS, EXCEPT FOOTBALL)

CAA Article III, Eligibility, 3.05 states: A student-athlete in a conference sport that has ever been the recipient of athletically related financial aid at a CAA institution who decides to transfer within the conference must fulfill two academic years of residence (per NCAA Bylaw 14.5.1.1) prior to being certified eligible for competition. The CAA Intraconference Transfer Rule also applies to an incoming student-athlete that has signed a valid National Letter of Intent with a CAA institution. Likewise, by general agreement, the original institution will have no objection to a waiver of the transfer residence requirement for the intraconference transfer of a student that has never received athletically related financial aid at the first CAA institution.
