NCAA AMA ONLINE CASE MANAGEMENT SYSTEM

The AMA Online Case Management System was launched on Monday, February 28. AMA Online Case Management is a centralized case processing system for institutions to submit and manage waiver and reinstatement cases, communications and decisions. All waiver and student-athlete reinstatement requests submitted February 28 and thereafter must be submitted via the AMA Online Case Management System. Any waiver or reinstatement case that is submitted prior to February 28 will continue to be processed via the previous method. Guidelines, policies and procedures for each case type and other helpful documents are located on the Resources tab within the AMA Online Case Management System.

AMA Online Case Management, the new waiver and student-athlete reinstatement processing system, is available behind the Single-Source Sign-On System. Single-Source Administrators may add access to the application prior to its launch. Administrators should expand the application once it has been assigned to be sure individual roles and privileges are selected to provide the user appropriate access levels. The function for "Request a case" will be defaulted to "Yes" if the application is assigned to a user. If there is a user that should be able to view information in AMA Online, but should not be able to initiate a case, the access level should be changed to "No." There is a <u>user guide</u>and <u>tutorial video</u> available to assist users on the Help tab within the Single-Source Sign-On System. CAA Reminder: With the NCAA Men's and Women's Basketball Tournament starting this month, we wanted to take this time to remind all student-athletes, coaches and staff of the NCAA's policy on gambling. The NCAA membership has adopted specific rules prohibiting athletics department staff members and student-athletes from engaging in gambling activities as they relate to intercollegiate or professional sporting events. NCAA member colleges and universities have defined sports wagering as putting something at risk – such as an entry fee – with the opportunity to win something in return. Because of this, student-athletes, coaches and staff may not participate in leagues or pools where there is both a required entry fee and an opportunity to win a prize. EDUCATIONAL COLUMN- - BYLAW 13.1.7.1.8- - EVALUATION DAYS- - BASKETBALL- - ATTENDANCE AT SCHOLASTIC AND NONSCHOLASTIC EVENTS DURING THE ACADEMIC YEAR

Educational Column:

February 18, 2011

NCAA Division I institutions should note the following restrictions apply to evaluations in men's and women's basketball during the academic year:

Men's Basketball

Mar 1– Mar 15 ~Evaluation Period Mar 16– Mar 22~Contact Period Mar 23– Mar 30~Evaluation Period Mar 31~ Dead Period

*All live evaluations during academic year shall be limited regularly scheduled high school, preparatory school and two-year college contests/ tournaments, practices and regular scholastic activities involving student-athletes enrolled only at that institution.

General

For purposes of applying the legislation, a regular scholastic activity is any activity involving only students enrolled at a particular high school, preparatory school or two-year college that has been approved by the appropriate authority at the scholastic institution. An activity that is organized for the purpose of allowing a college coach or coaches to observe prospects demonstrating their athletics skill is not considered a regular scholastic activity and would constitute an impermissible tryout.

Men's Basketball

- 1. During the academic year evaluation periods and the March and April contact periods, evaluations are limited to regularly scheduled high school, preparatory school and two-year college contests/tournaments and practices and regular scholastic activities involving student-athletes enrolled only at the institution at which the regular scholastic activities occur.
- For example, Division I men's basketball coaches may attend high school pick-up games during a designated contact or evaluation period during the academic year, provided the activity has been approved by the appropriate authority at the high school as a regular scholastic activity and involves only students enrolled at the high school where the activity is occurring. Institutions should note that the pick-up games may not be scheduled in consultation with an institution's coach or organized for the purpose of permitting institutional coaches to observe the prospective student-athletes participating in the activity.

Women's Basketball

Mar 1- Mar 31 ~ Contact Period

2. Evaluations may occur at the National Basketball Association predraft camp.

Softball

Mar 1- Mar 31 ~ Contact Period

Women's Basketball

1. During the academic year, evaluations may occur at regularly scheduled high school, preparatory school and two-year college contests/tournaments, practices, pick-up games and open gyms.

Women's Volleyball

Mar 1- Mar 31 ~ Contact Period

2. During the last full weekend of the fall contact period and the weekend of the spring evaluation period, evaluations at nonscholastic events that are certified per NCAA Bylaw 13.19, including events that are approved, sponsored or conducted by an applicable state, national or international governing body but are organized and conducted primarily for a recruiting purpose are permitted.

Men's Lacrosse

Mar 1- Mar 31 ~ Contact Period

3. Evaluations may occur during an evaluation period at nonscholastic events that are approved, sponsored or conducted by an applicable state (e.g., state high school association), national (e.g., National Junior College Athletic Association) or international governing body (e.g., USA Basketball, United States Olympic Committee or international equivalent) and are not organized and conducted primarily for a recruiting purpose.

Women's Lacrosse

Mar 1- Mar 31~ Contact Period
