National Letter of Intent Makes Changes for 2007-08 Signing Class

For 2007-2008, the National Letter of Intent has new requirements. The following addresses each provision and the changes for the upcoming signing periods.

- NLI Provision 2 A National Letter of Intent
 must be provided with an offer of athletics aid
 applicable for the entire 2007-2008 academic
 year. NLIs with offers of aid for one semester
 or one/two quarters cannot be validated by
 the conference office. Furthermore, in order
 for the NLI to be valid, the prospect and the
 prospect's parent/legal guardian both must
 sign the NLI and financial aid agreement.
- NLI Provision 7d This provision states a
 National Letter of Intent is null and void if a
 signee serves in the U.S. Armed Forces or on a
 church mission for a specified period of time.
 The intent of the policy is unchanged, and new
 NLI language lowers from 18 to 12 months the
 length of service required for the NLI to be
 null and void. It also removes the requirement
 that the church mission be "official."
- NLI Provision 7f This provision states that in the event of a recruiting violation involving an NLI signee, the Letter only becomes null and

void after the enforcement process is complete and all appeals for restoration of eligibility are exhausted. New language has been added to explain an NLI will be null and void if a recruiting violation results in the need for eligibility reinstatement. (NOTE: The outcome of the reinstatement decision is not relevant to the status of the NLI.)

- NLI Provision 13 This provision states a National Letter of Intent must be signed within 14 days from the date of issuance in order to be valid. New language has been added to further require the accompanying financial aid agreement to be signed within 14 days from the date of issuance as well.
- NLI Provision 14 This provision states a National Letter of Intent must be filed with the conference within 21 days after the date of final signature or it will be invalid.
- It is not permissible to issue National Letters of Intent in the sport of Men's Rowing.

Rule Change -- Outside the Playing Season

Effective August 1st of this year, the rules governing "Dutside the Playing Season" changed. These changes included Bylaws 17.1.5.2(a) and 17.1.5.2.2.

Athletic Related Activities Outside the Playing Season for sports other than Football.

<u>Time Limits</u> - All required weighttraining, conditioning and individual skill instruction limited to a maximum of eight hours per week with not more than two hours per week spent on individual skill workouts.

Exam Period - All of these athletically related activities are prohibited one week prior to the beginning of the final examination period through the conclusion of each student-athlete's final exams.

Skill Instruction - More than four student-athletes from the team may be involved in skill-related instruction with their coaches during the period September 15 through April 15.

Reporting Violations

A Secondary Violation may occur during the academic year. In order to appropriately report them follow these steps.

- Check the NCAA website to determine if the violation is a Level I or Level II.
- 7. If Level I, send report to NCAA and copy CAA.
- 3. If Level II, send report to CAA.
- If reporting a Level II violation to the conference office, use the Secondary Violation Form. Use the Level 11 Secondary Violations Chart to assist you in determining the appropriate penalties. Both documents can be found on the CAA Compliance Corner website.
- If reporting a Level I violation, use CAA form or NCAA Secondary Violation Report form on NCAA website.



Question of the Month

Can a high school team have a "bake sale" fundraiser at an institutional contest?

Answer: Per Bylaw 13.15.1 it is not permissible for a high school team to have a "bake sale" fundraiser at an institutional contest. An institution cannot offer, provide or arrange financial assistance directly or indirectly benefiting prospective student-athletes. In this case, because the institution is providing the venue and potential

customers, the prospective studentathletes would receive a direct benefit (e.g. monies raised from the sale of baked goods at campus athletics events).
