As the Fall Season Begins, Questions of Countable Coaches Arise

Countable Coaches

The fall season began a month ago for fall sports. However, after a few contest some coaching staffs are not yet complete. Some schools are looking to their sport counterparts to help with day-to-day coaching activities. For example, a coach from the Women's Track team assisting the Men's team during Now the question practice. becomes who's countable? In the above example, the coach from the women's track team would be countable for both the women's and men's teams. Per Bylaw 11.7.4.2, if a coach is paid/designated to fill the coaching category of head or assistant coach through the athletic department, he/she is a countable coach. In addition, the only way the women's coach could continue to assist the men's team is if the men's team has not reached its countable coach limit.

Volunteer Coaches

Another way for coaches to gain additional help with coaching is through volunteer coaches. sports other than football and basketball, a volunteer coach may be utilized. A volunteer coach is a coach that does not receive payment from the athletic department for performing coaching Bylaw 11.01.5 states, "In sports other than football and basketball, a volunteer coach is any coach who does not receive compensation or remuneration from the institution's athletics department or any organization funded in whole or in part by the athletics department or that is involved primarily in the promotion of the institution's athletics program (e.g., booster club, athletics foundation association). The following provisions shall apply: a) The individual is prohibited from contacting and evaluating prospective studentathletes off campus or from scouting opponents off campus and may not perform recruiting coordination functions;

- b) The individual may receive a maximum of two complimentary tickets to home athletics contests in the coach's sport;
- c) The individual may receive complimentary meals incidental to organized team activities (e.g., preor post game meals, occasional meals, but not training table meals) or meals provided during a prospective student-athlete's official visit, provided the individual dines with the prospective student-athlete."
