# Reminder: Proposal 2007-42 / 2008 Spring Evaluations Period

April 15-May 31, 2008 is designated as a Football Evaluation Period. Proposal 2007-42, which added additional restrictions to evaluations in Bylaw 13.1.8.9.4, was adopted in January 2008 with an immediate effective date.

#### Proposal 2007-42

All evaluations, including evaluations that occur during the 2008 spring evaluation period, are limited to regularly scheduled high school, preparatory school and two-year college contests and practices and regular scholastic activities involving prospective student-athletes enrolled at the institution at which the regular scholastic activities occur. Therefore, evaluations may not occur at nonscholastic events, including, but not limited to, camps, combines and all-star games.

**Bylaw 13.1.8.9.4**—Scholastic and Nonscholastic Activities

In football, all athletics evaluations shall be limited to regularly scheduled high school, preparatory school and two-year college contests and practices and regular scholastic activities involving prospective student-athletes enrolled only at the institution at which the regular scholastic activities occur.

### Bylaw 12.5.3 Media Activities

#### 12.5.3 (B) Outside the Playing Season

Outside the playing season, a student-athlete may participate in media activities (e.g., appearance on radio, television, in films or stage productions or participation in writing projects) when such appearance or participation is related in any way to athletics ability or prestige, provided the student-athlete is eligible academically to represent the institution and does not receive any remuneration for such appearance or participation. The student-athlete may not make any endorsement, expressed or implied, of any commercial product or service. The student-athlete may, however, receive legitimate and normal expenses

directly related to such appearance or participation, provided the source of the expenses is the entity sponsoring the activity.
