Tuesday, April 30, 2013, via teleconference call

1. **NCAA BASEBALL COMMITTEE REPORT**: Kevin Brooks (ASU) and Jason Gonzalez (TAMUK) gave a report of their service on the South Central Regional Advisory Committee, explaining the criteria and process for determining regional rankings and postseason selection.
2. **FUTURE BASEBALL SCHEDULES**: The group accepted the 2014 schedule, which already has been approved, and discussed possibilities for the 2015 schedule. No action was taken.
3. **2014 LSC TOURNAMENT SITE**: The group tabled discussion of the site for the 2014 LSC Baseball Championship tournament until after the 2013 event. No action was taken.
4. **BALL AGREEMENT**: The group tabled discussion of the Diamond renewal proposal to allow for solicitation of a proposal from Rawlings. No action was taken.
5. **SUNDAY START TIME**: It was moved (ENMU) and seconded (ASU) to eliminate from LSC Baseball Operating Code #3 the restriction that "No Sunday games shall start before 1:00 PM." **Passed unanimously.**
6. **FUTURE MEETING DATE**: Consensus agreement was to set date for the next meeting on Tuesday, May 6, 2014.
7. **ELECTION OF OFFICERS**: It was moved (ENMU) and seconded (ASU) to appoint Bryan Conger (TSU) as Vice Chair, effective Sept. 1, 2013 through the 2014-15 academic year. **Passed unanimously.**
