# 2013 Tennis Championships

## **Pre/Post-Championship Teleconference**

A teleconference will be held prior to the Championships on April 2, 2013 to give an overview on championship procedures, rules, and policies. A teleconference will also be held following the Championships on April 30, 2013. Participation by each head coach is mandatory.

## **Coaches Meeting**

A meeting of the coaches will be held at the Millbrook Tennis Center at 3:00pm on Thursday, April 18, 2013 to review championship procedures, rules and policies. Attendance by each head coach is mandatory.

## **Format**

Matches shall consist of three (3) eight-game, pro-set doubles played for one team point, followed by six singles matches, each valued at one team point, played best of three sets. Regular scoring will be used. The team winning four or more team points advances. The Championship is single elimination.

## **Line-Ups**

All team lineups must be submitted to the MEAC Office no later than Monday, April 8. Coaches shall enter players in rank order according to ability. Any or all of the singles players may participate in the doubles matches. In singles competition, positions 1-5 shall remain the same for the duration of the championship. Substitutions may only be made to position 6.

A minimum of five (5) players are required to begin a match. When an institution has fewer than the six (6) players necessary for a full team match, shall be played as scheduled and the defaulted individual matches shall be placed at the bottom of the ladder. If any doubles player is injured after the submission of the lineup, a straight-line (direct) substitution may be made.

## **Substitutions**

Head coaches shall inform the referee of any changes to the lineup. In the case of injury, illness, or extenuating circumstances (as approved by the games committee) a replacement can be made in the lineup. In such cases, the lineup must remain in order of strength, with student-athletes moving up one (1) place in singles and the new player being placed in the number six (6) position.

For doubles competition, any replacement must be a straight-line replacement. The three (3) doubles teams must remain in order of strength as determined by their competition records.

The games committee is required to review each institutions line-up to insure compliance with the rules governing process.

## **Practice**

Practice times will assigned from 10:00am – 2:00pm on April 18 in one hour increments based on distance from Millbrook Tennis Center. (Institution closest to Raleigh, NC will have earliest time, while institution furthest from Raleigh, NC will have latest time.)

## **Event Entries**

Championship rosters should be submitted to the MEAC Office by an institutional compliance officer not later than March 18, 2013.

## **Squad Size**

The squad size shall be a maximum of eight (8) participants and the travel party shall be a maximum of twelve (12).

## **Awards**

Regular season awards for Divisional Champions, All-Conference First Team, will be awarded.

Team awards for the Champion and Runner-up team will be provided along with individual awards to the number one singles (first place); number one (1) doubles (first place); the Outstanding Tournament Coach (Coach of Champion Team); and the Outstanding Performer at the conclusion of the Championship.

## **Games Committee/Jury of Appeals**

The games committee/jury of appeals shall consist of the Director of Championships, Head Official, Co-Chairs of the Tennis Championships, and President of the Tennis Coaches Association. The decision of the Games Committee/Jury of Appeals is final.

## **Media**

**Results:** Results will be updated on the conference web site immediately following each day's competitions. Results will also be e-mailed to all MEAC SIDs, head coaches and media outlets at the conclusion of each day.

**Post-Championship Interviews:** Post championship interviews will take place in a designated media area immediately following the championship photos and all-tournament team announcements.

## **Sportsmanship**

The MEAC proposes to promote mutual trust and friendly relations among its members by controlling athletic competition and keeping such competition within the bounds of sound educational activity; by promoting clean sportsmanship; and by developing public appreciation for the educational values that accrue from participation in intercollegiate athletics.

The officers and administrators of the MEAC place a high premium on professionalism, sportsmanship, and ethical conduct. As such, there are significant penalties for any breach of conduct during the course of regular season competition and to an even greater extent during the conduct of MEAC Championships.

For the purposes of general definition, misconduct in a MEAC Championship is any act of dishonesty, unsportsmanlike conduct, unprofessional behavior or breach of law on the part of any recognized University representative, occurring incident to, en route to, from or at the locale of the competition or practice that discredits the event or intercollegiate athletics.

## **Misconduct Incident to Competition**

If the act of misconduct occurs during the competition, under normal circumstances, the individual shall be allowed to complete the competition in which he or she is participating at the time of the incident. An administrative hearing shall be held at the conclusion of the day's competition, during a break in the continuity of the championship (e.g., between rounds of basketball tournament) when no competition is being conducted, or at the conclusion of the championship. However, if the act of misconduct is so flagrant that it obviously violates the principles of fair play and sportsmanship, the games committee may immediately withdraw the student-athlete or institutional representative from the competition, and conduct the hearing after this action. Other acts of misconduct may be dealt with at the sports committee's convenience.

## **Penalty for Misconduct**

The sports committee (or games committee authorized to act for it) may at its sole discretion impose any one (1) or a combination of the following penalties on an institution or any student-athlete or representative of any institution, guilty of misconduct occurring incident to, en route to, from, or the locale of the competition or practice.

- (a) Public or private reprimand to the individual;
- (b) Disqualification of the individual from further participation in the Conference Championship (s) involved;

- (c) Banishment of the individual from participating in one (1) or more subsequent championships of the sport involved;
- (d) Withholding all or a portion of the institution's share of revenue distribution;
- (e) Banishment of the institution from participation in one (1) or more subsequent championships in which its team in the sport otherwise would be eligible to participate;
- (f) Financial Penalties shall be as follows:
  - a) First Offense - \$500 institutional fine and letter of reprimand
  - b) Second Offense - \$1,000 institutional fine
  - c) Third Offense - \$2,000 institutional fine and one (1) game suspension for the offending coach, institutional staff member and/or student-athletes

### **Ban from Subsequent Championship**

When a student-athlete or institutional representative is banned from participation in a subsequent championship, such penalty shall be applied to the next Conference Championship events in which the individual's team is involved and the individual otherwise is eligible to participate. In the case of an individual event, the penalty shall be applied to the next Conference Championship event(s), meet(s), or tournament(s) for which the individual qualifies and otherwise is eligible to participate.

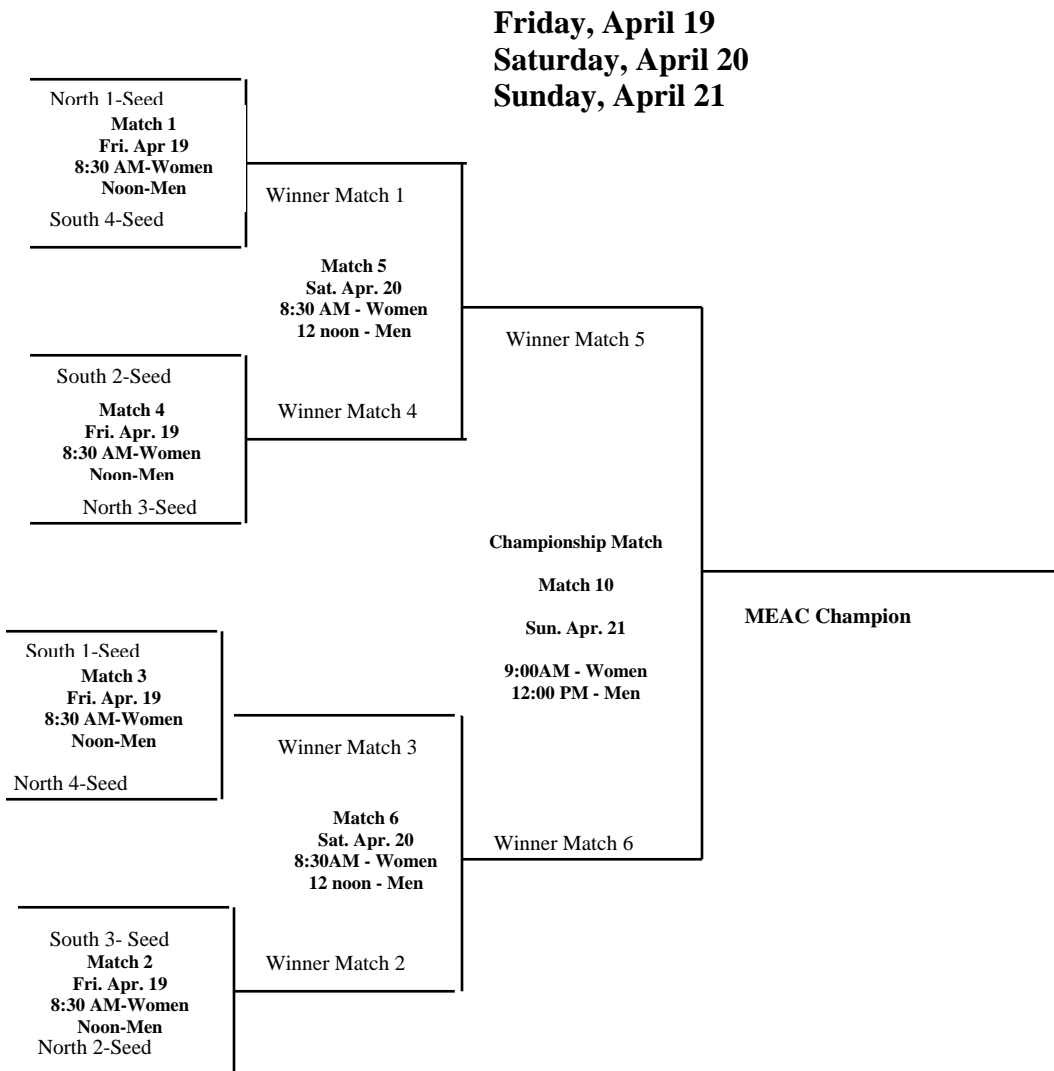
