as the Bulldogs' top singles player.




MVC Doubles Team of the Week



Of the eight players on Bradley's roster, senior Aimee Manfredo has been out all season due to injury, sophomore Natalia Barbery and senior Alejandra de Lasa were hobbled by knee injuries last weekend, while freshmen Victoria Gonzalez and Sandra Maletin both were down with the flu ... Barbery, de Lasa, Gonzalez and Maletin all are expected back in the lineup during the California trip.

FIRST-EVER TRIP TO CALIFORNIA

Next week's spring break trip to Southern California will mark the first-ever visit to the state of California for the Bradley Women's Tennis program ... While trips to warm weather climates are common during the school's annual spring break, the Braves had never before ventured farther west than Las Vegas ... Two of the matches during the trip will be played at UC Riverside and UC Irvine ... Bradley has played only one previous match against a California based program - a 5-2 win against Cal State Bakersfield March 16, 2009 in Las Vegas.
