# Semifinal Pairings Set Following Opening Day of 2014 NEC Tennis Championships

**West Windsor, NJ** -- The quarterfinal round of the 2014 Northeast Conference Tennis Championship is in the books, and while each of the top-three men's and women's seeds advanced, the day did provide a pair of surprises with two #5 seed over #4 seed upsets. The tournament for the fourteenth straight year is being contested at the Mercer County Tennis Center in West Windsor, New Jersey.

Under bright sunshine and brisk temperatures, top-seeded Bryant men delivered a dominant performance in its 4-0 win over #8 St. Francis Brooklyn. The Bulldogs dropped just six games in singles play, including a trio of 6-0, 6-0 wins. Bryant will face fifth-seeded Sacred Heart in Friday's semifinals. The Pioneers pulled off a minor upset over fourth-seeded Robert Morris behind freshman **Anthony Savio (Bangalore, India)**, who outlasted RMU's **Juan Andres Hirmas (Santiago, Chile/Monte Tabor)**, 7-6 (4), 7-6 (5).

The second men's semifinal will pit two-time defending NEC Champion and #2 seed Fairleigh Dickinson against #3 Saint Francis U. The Knights opened play with a 4-0 win over #7 Wagner while the Red Flash rallied from a set down in three singles matches to upend #6 Mount St. Mary's, 4-2. SFU advances to its first semifinal since to the 2001 season under first year head coach Rob Castille.

On the women's side, top-seeded Fairleigh Dickinson began its quest for a three-peat with a 4-0 triumph over #8 Wagner. Two-time NEC Rookie of the Week **Ksenija Tihomirova (Riga, Latvia)** rolled to a 6-0, 6-1 win at #1 singles for the Knights. Next up for FDU is a semifinal match-up with #5 seed Saint Francis U. The Red Flash ousted #4 Sacred Heart by a 4-2 count in the final match of the day.

Perennial contender LIU Brooklyn, seeded second, dispatched #7 Mount St. Mary's, 4-0 and will now face #3 Bryant, which advanced to its first-ever NEC semifinal with a 4-0 victory over #6 Robert Morris.

In the lone feed-in match of the day, the #8 seeded Wagner women opened the tournament with a 4-0 win over #9 St. Francis Brooklyn.

Action begins on Friday at 10:00 am with the two men's semifinal matches. The women's semis will follow not before 12:30 pm. The men's and women's championship matches will culminate the three day tournament on Saturday. The two winners will go on to represent the NEC in the NCAA Tournament.
