Northern Sun Intercollegiate Conference Conference Council Meeting Report

January 16, 2025

Action Items.

1. Recommendation. To approve the minutes from the July 10, 2024, Conference Council Meeting.

Unanimously Approved by the Conference Council.

Informational Items.

- 1. <u>Approval of July 2024 Meeting Minutes</u>. The group reviewed the minutes from the July 10, 2024, Conference Council Meeting. No further discussion was had, and a recommendation was made to approve the minutes.
- 2. 2025 NCAA Legislative Summary. The group was given a summary of the proposals on the floor at the 2025 NCAA Convention. Discussion was had on the football automatic qualification (AQ) proposal with pros and cons of the proposal shared. It was noted that if the football AQ proposal is adopted, championships policy would trigger a review of bracket expansion in football. Discussion was also had on the medical examination proposal. It was noted the bylaw 17 portion of the proposal is a common provision and will require Divisions I and III to adopt similar language for a legislative change to go into effect even if Division II adopts the medical examination proposal.
- 3. Strategic Planning Update. Jill Willson, Double L Consulting, provided an update on the recent progress and efforts made in the development of the future NSIC strategic plan. Gratitude for the invaluable contribution of the student-athletes' voices was shared. The in-person session was particularly beneficial, offering the strategic planning committee an opportunity to discuss aspirational goals and strategies for the development of the future strategic plan. For next steps, Double L Consulting will synthesize the key points raised during the in-person meeting and translate those ideas into actionable outcomes for the strategic planning committee to review. Jill reminded the group that the process remains ongoing and encouraged the group to continue sharing feedback.
- 4. <u>University of Jamestown Update</u>. Dr. Polly Peterson, University of Jamestown, provided an update on the University of Jamestown's (UJ) expedited process. Recently UJ had an onsite visit from the NCAA and received feedback on both areas the institution is doing well and recommendations. UJ expressed gratitude for the support it has received from the conference membership throughout the transition. A reminder was provided that UJ will begin competing in NSIC competition schedules in the fall of 2025. During the 2025-26 academic year, UJ is eligible to win regular season championships, but is ineligible to participate in NSIC championships that have an automatic qualification tied to it.
- 5. <u>U.S. Council for Athletes' Health.</u> Angie Beisner from the United States Council for Athletes' Health (USCAH) provided an update on the organization's ongoing initiatives aimed at supporting and educating the league. USCAH is focused on uplifting the conference through various programs, including mental health series, the student-athlete advisory committee (SAAC) group, and continuing education for athletic trainers. A reminder was provided that USCAH offers a Health Care Administration group, which is available to all athletic trainers. This group provides an opportunity for athletic trainers to access education, training, and updates relevant to their field. The current shortage of athletic trainers in collegiate athletics was discussed.

Institutions were encouraged to review a recent resource document released by the NCAA regarding hiring and retention of athletic trainers. A final reminder was given to utilize USCAH as a valuable resource moving forward.

6. NSIC Network Update. The group was reminded the current contract with Hudl expires in June of 2026. The 2024-25 academic year marks the second year of the Pilot Project, which involves moving select championships behind a paywall. An update was provided that the Board of Directors agreed during its 2025 spring meeting, it will discuss and act on a path to take with webcasting – pursue a pay-per-view or a free-to-view model. In preparation for the Board's meetings, an executive summary is being built, which will be shared and discussed with the conference council in the coming months.

7. NCAA Committee Updates.

- a. <u>Division II National Student-Athlete Advisory Committee.</u> Davaris Cheeks, National SAAC Representative from Concordia University, St. Paul provided an informative overview to the council on how the legislative grids function at the Division II level. He guided the group through the current proposals, highlighting which ones the National SAAC support and which they oppose. National SAAC's goals were outlined, which include empowering, enhancing, and empathizing; as were the two major initiatives from the year, execution of civic engagement efforts and the development of an internal resource document to support SAAC. Congressional engagement continues to remain highly active and additional resources will be provided in the coming months. Davaris' term on National SAAC is complete at the end of Convention. Davaris was thanked for his tremendous service on National SAAC.
- b. <u>Division II Executive Board</u>. Dr. Steven Shirley, Minot State University, provided an update from the NCAA Division II Executive Board. Several legal updates were provided that relate to the ongoing political changes impacting college athletics. An update was also provided in the space of sports wagering. The key issues of student-athletes not being classified as employees; name, image, and likeness; and the ability for the NCAA to receive federal anti-trust protection remain at the forefront of congressional engagement.
- c. <u>Division II Management Council.</u> Commissioner Lind provided an update from Management Council. The council approved the use of surplus funds for the 2024-25 academic year, with \$8,000 allocated to each institution. The Sport Science Institute is working to reenergize the injury surveillance program. Data collected through this initiative has proven to be critical in supporting the health and safety efforts within the league. The group was informed that Jennifer Flowers, Southwest Minnesota State University, was appointed as an at-large member to the Management Council.
- d. <u>Division II Membership Committee</u>. Melanie Brunsdon, Winona State University, informed the group Membership Committee's next meeting will be in February.
- e. <u>Division II Championship Committee</u>. Regan McAthie, Concordia-St. Paul, provided an update to the group regarding Championship Committee's evaluation of potential changes to the selection process. The committee is considering moving from a committee-based selection system to a metric-based selection system. Two metrics discussed: KPI (Kevin Pauga Index) and NPI (NCAA Power Index). Both metrics have their respective pros and cons. An experiment was conducted comparing the use of KPI, NPI, and NPI with adjusted dials similar to the current approach in Division III. The results showed an 85-94% match in the outcomes, providing valuable insights into the potential impact of switching to a metric-based system. The Championships Committee's goal is to bring forward a recommendation on the selection system by June 2025.

f. <u>DII Athletic Directors Association.</u> Britt Lauritsen, Bemidji State University, provided an update from DII ADA. The group was encouraged to attend NACDA, scheduled for June 8-11, as well as submit any potential topics for presentation that would be relevant or valuable. Current discussion topics for the conference include KPI vs NPI, athletic training, and the use of AI in athletic departments. The Spring Symposium for athletic directors is set for April 13-14 in Charlotte, with registration now open.

Northern Sun Intercollegiate Conference SAAC Business Meeting Report

May 20, 2025

Action Items.

1. <u>Recommendation.</u> To approve the minutes from the May 21, 2024, Conference SAAC Business Meeting.

Approved by the Conference SAAC 14-0.

2. <u>Recommendation.</u> To approve the 2025-26 NSIC SAAC initiatives: Mental Health Awareness, utilizing the Green Bandana Project; Wellness & Belonging; It's a Slam Dunk, Don't Drive Drunk; and Life after College.

Effective Date. 2025-26 Academic Year.

Rationale. The group agreed that all the 2024-25 SAAC initiatives (Mental Health Awareness, utilizing the Green Bandana Project; Diversity, Equity, & Inclusion (DEI); It's a Slam Dunk, Don't Drive Drunk; and Life After College) are still topics that should be continued during the 2025-26 academic year. The title for Diversity, Equity, & Inclusion was adjusted to Wellness & Belonging to closely align with how the NCAA has renamed DEI.

Approved by the Conference SAAC 14-0.

3. <u>Recommendation.</u> To adopt the following timeline for when SAAC cup points must be submitted by:

SAAC Cups items in all categories except Make-A-Wish donations & Financial Contributions to Worthy Causes must be submitted to the conference office by the quarterly deadline in which the meeting/event/initiative/project takes place.

- All items that take place in September & October must be submitted by November 15.
- All items that take place in November & December must be submitted by January 15.
- All items that take place in January & February must be submitted by March 15.
- All items that take place in March & April must be submitted by May
 7.

Receipts or check orders for Make-A-Wish/Financial Contributions to Worthy Causes must be submitted to the conference office by May 7.

Any items for the NSIC SAAC Cup submitted after the appropriate deadline will not count as points for the NSIC SAAC Cup.

Effective Date. 2025-26 Academic Year/2025-26 NSIC SAAC Cup.

Rationale. Currently the NSIC SAAC Cup criteria does not outline a timeline for when items need to be submitted in relation to when a meeting/event/initiative/project takes place. For example, an institution can wait to submit all items from the year at the end of the academic year. To improve the accuracy of standings released during the academic year and to increase

accountability for all SAAC groups to submit points in a timely fashion, the group agreed establishing a timeline for when SAAC cup items must be submitted in order to count as points towards the SAAC Cup was beneficial.

Approved by the Conference SAAC 14-0.

4. Recommendation. To add to the NSIC SAAC Cup criteria the following language:

To be eligible to win the NSIC SAAC Cup, at least one student-athlete from the institution must be in attendance for the duration of the SAAC Summit to accept the award. If the winning institution does not have at least one student-athlete in attendance, the NSIC SAAC Cup will be awarded to the institution with the next highest point total that has a student-athlete in attendance for the duration of the SAAC Summit.

Effective Date. 2025-26 Academic Year/2025-26 NSIC SAAC Cup.

<u>Rationale.</u> The group felt that having at least one student-athlete from the winning institution in attendance to accept the award and participate in the duration of the SAAC Summit is an important aspect of the SAAC Cup. Noting that the SAAC Cup sponsor is on-site to present the award, the SAAC Cup is a student-athlete driven award, and the SAAC Summit is an integral part of SAAC.

Approved by the Conference SAAC 14-0.

5. <u>Recommendation.</u> To add to the NSIC SAAC Cup criteria the following language:

At least one student-athlete from an institution must be in attendance for the duration of the SAAC Summit in order to be eligible to win the NSIC SAAC Cup the following academic year, with the exception of an institution that is still in class/finals.

Effective Date. 2025-26 Academic Year/2026-27 NSIC SAAC Cup.

<u>Rationale.</u> Currently the NSIC SAAC Cup criteria outlines that attendance at the SAAC Summit is added to the following academic year's SAAC Cup points (i.e. attendance at the 2026 SAAC Summit is added to the 2026-27 NSIC SAAC Cup points). The group felt it is important that institutions have at least one student-athlete in attendance for the duration of the SAAC Summit to be eligible to win the NSIC SAAC Cup the following year as SAAC Summit is an integral part of SAAC.

Approved by the Conference SAAC 14-0.

Informational Items.

- 1. <u>Welcome.</u> The group was welcomed and thanked for their commitment to elevating the conference and institutional SAAC by attending the SAAC Summit.
- 2. <u>Approval of May 21, 2024, Meeting Minutes.</u> The group reviewed the minutes from the May 21, 2024 Conference SAAC meeting. There was no further discussion, and a recommendation was made to accept the minutes.
- 3. <u>National SAAC Update.</u> Connor Fournier, Minnesota State University, Mankato and National SAAC representative for the NSIC, gave an update on behalf of National SAAC. Of note,

National SAAC reviewed the timing of the NCAA DII football championship, the group was in favor of keeping the timing as is and not pushing it back to January. National SAAC received an update on the DII Eligibility Working Group, a working group that has been formed to perform a comprehensive review of Division II eligibility rules. National SAAC provided feedback on the following four eligibility concepts the working group is considering: (a) four seasons of competition in 10 semesters, (b) four seasons of competition within a five-year clock following initial collegiate enrollment, (c) five seasons of competition within a five-year clock following initial collegiate enrollment, and (d) five seasons of competition in 10 semesters. Regarding sports wagering, DI, DII and DIII have concept drafts of deregulation of sports wagering on professional sports. - 4. 2025-26 NSIC SAAC Initiatives. The group was thanked for their time in providing valuable feedback through the NSIC SAAC initiatives survey. An overview of the survey results was provided. The group had healthy discussion reflecting on the 2024-25 academic year and shared implementation ideas with one another. Of note, the mental health initiative scored the highest mark across all institutions on the reflection survey for wanting to continue the initiative. Members shared how their institution implemented the Diversity, Equity, & Inclusion initiative – some partnered with their campus' international and diversity center, some focused on creating environments of belonging across all student-athletes, while others engaged with Special Olympics. For It's a Slam Dunk, Don't Drive Drunk, the group discussed ways they can refresh this initiative on their campus. For the group's newest initiative, Life After College, a mixture of feedback was given. Members shared how their institution implemented the Life After College initiative – some hosted alumni panels, some worked with their career center for programming, while others had outside companies provide skills development programming to student-athletes. Overall, the group agreed that these four initiatives were impactful and meaningful on their campuses. From discussion, the group agreed to continue the same four initiatives moving forward into the 2025-26 academic year, while transitioning the title of DEI to "Wellness and Belonging". A recommendation was made and can be referenced as action item two.
- 5. NSIC SAAC Cup Review. The group reviewed the criteria to earn points towards the NSIC SAAC Cup. Discussion was held regarding a quarterly deadline to submit items that are allocated towards an institution's point total. The timeline would allow for accountability and accuracy when SAAC Cup standings are released throughout the year. Healthy discussion was had regarding the importance of attending the SAAC Summit. The group agreed to add criteria to the SAAC Cup that in order for an institution to accept the award as well as be eligible for the award the following year, at least one student-athlete must attend the SAAC Summit. Lastly, the group discussed the percentage financial contributions count towards SAAC Cup points in relation to other events. A working group has been identified and will review the financial point system. Recommendations were made for the timeline and requirements in attending SAAC Summit, the recommendations can be referenced as action items three through five.
- 6. NSIC Strategic Plan Update. The group was informed that the NSIC strategic plan is a guiding tool for helping the conference move forward and grow in a strategic way. Over the past academic year, a working group made up of a variety of individuals, including student-athletes, reviewed and identified goals for the next five years. During its meeting, the NSIC Board of Directors approved the 2025-30 NSIC Strategic Plan. As part of the strategic plan, the group was asked for feedback on sportsmanship voting and the NSIC Influencers of Change Pledge. Members shared feedback that they felt the avenue for collecting sportsmanship voting worked well overall. For track and field, members noted it is hard to always provide accurate information due to all the different events in the sport. Members shared feedback on the NSIC Influencers of Change Pledge that they felt sharing the message prior to contests had a positive impact on fans.

7. <u>Open Discussion.</u> The group engaged in discussion on campus SAAC set up and planning initiatives for the 2025-26 academic year. Additionally, the group shared ways they are implementing mental health awareness including a new resource through Hilinski's Hope (www.hilinskishope.org).

ACADEMICS & LIFESKILLS

- o Further celebrate academic achievement across the conference and on campuses.
 - Review all current academic awards to ensure they reflect the current studentathlete population considering the many paths student-athletes are taking (e.g., freshman enrolling with several credits from high school, graduate students, fifth-year students).
 - Evaluate adding team academic awards (e.g., recognize teams with a team GPA of 3.2 or higher).
 - Recognize graduates.
 - Recognize prominent civic/community engagement.
 - Celebrate academics at championships
- o Develop a Student Success Model, including resources and a framework for faculty athletic representatives and the membership to use.
 - Create a sharing platform for faculty athletics representatives that includes job descriptions, attendance policies, academic expectations, and best practices for different aspects of the role.
- o Develop initiatives to help student-athletes transition to life after college.
 - Evaluate type of programming to target different years in college potentially life skills learned through sport for freshmen and sophomores (e.g., time management, navigating playing time) and after college life skills for juniors and seniors (e.g., creating resumes, financial literacy, health insurance).
 - Expand programming to reach all student-athletes on campus, not just SAAC members
 - Educate students on what campus resources are available for different academic/career pursuits.
 - Create an NSIC Leadership Academy to which student-athletes apply and are matched with administrators and coaches as mentors (similar to the D2ADA mentor program).































ATHLETICS OPERATIONS AND COMPLIANCE

- o Create a resource to update student-athletes on key initiatives.
 - Provide updates on changes in Division II and how they affect the NSIC (i.e., quick hitters via a newsletter or podcast on new legislation and what it means).
 - Provide compliance education/training for other departments on campus that have a stake in compliance (e.g., registrar, financial aid, admissions, academic advising, FARs, etc.).
- Emphasize ethical conduct.
 - Maintain high level of decorum within conference/campus operations and decision making.
 - Enhance enforcement and penalties for ethical misconduct.
 - Reevaluate sportsmanship policies and initiatives.
 - Look to combine sportsmanship creed and influencers of change pledge to address ethical conduct and a conference culture of ethical decision making.
 - Review NSIC championships code of conduct and incorporate the Division II Championships code of conduct.
- o Create/share best practices document for game day operations that provides minimum requirements for staffing appropriately.
 - Use game management policies that campuses have in place as a starting point.
- o Continue NSIC onboarding programming for new coaches and administrators hired within the conference membership.































GAMEDAY AND CHAMPIONSHIPS

- Ensure consistent/equitable experiences for all NSIC championships.
 - Evaluate how host institutions are supported.
 - Review/update host requirements for on-campus championship sites.
 - Evaluate championship trophies and awards create consistency across sports.
 - Review student-athlete gifts evaluate changing annually and staying current with what student-athletes are interested in.
 - Evaluate consistency with community engagement at championships.
 - Evaluate consistency with media exposure, multimedia/streaming experiences and hype videos.
 - Strive to make conference championships a first-class experience that differentiates from regular-season contests, especially when a championship is held on campus.

o NSIC Network.

- Evaluate webcasting goals.
- Evaluate how to enforce and penalize institutions that do not meet minimum standards of webcasting.
- Maintain quality and consistent standards for game day streaming.





























MEMBERSHIP AND POSITIONING

- Consider the feasibility of retaining an outside vendor to evaluate the status and reach of the NSIC brand.
- Track on emerging sports within the conference footprint for potential expansion opportunities.
- o Continue encouraging conference members to serve on NCAA committees and evaluate adding student-athletes to serve on NSIC committees.

HEALTH, WELLNESS AND LEADERSHIP

- o Continue USCAH partnership and programming.
 - Be cognizant of how to intrinsically motivate staff and coaches to attend wellness programming.
- Educate student-athletes, coaches and staff on accessible resources and tools that may not require financial support.
 - Educate student-athletes with self-care tools (e.g., building resilience, grit).
 - Be creative with platforms/avenues that can educate student-athletes (e.g., social media, sports psychologist).



The NSIC Spotlight, powered by gpac, completed its 23rd year in 2024-25. For the first 18 years, the NSIC Spotlight aired on local radio stations and more recently via podcast. The last fours years the NSIC Spotlight has been a zoom interview, highlighting a student-athlete guest. The NSIC Spotlight continues to be "The Voice of the NSIC Student-Athletes" as the video is distributed to fans via social media outlets (YouTube, X, Facebook, and Instagram), with an audio only format also available via podcast.



The NSIC continues to reach fans via multiple social media platforms. The NSIC X, Facebook, and Instagram accounts continue to grow due to the content of photos, videos, and other graphics that are posted. Features, highlights, and interviews are posted on all platforms, and the use of sport-specific hashtags have helped all NSIC social platforms followership to grow.









During the 2024-25 academic year the NSIC Network continued its success with 1,628 broadcasts. The NSIC Network combines live streaming and on-demand video content from all 15 members and NSIC Championships. Fans watched all their favorite team's action on the NSIC Network via their TV, computer, or smartphone. The NSIC Network is available on OTT platforms such as Apple TV, Roku & Amazon FireTV as well as mobile apps in the Apple & Google Play stores. In its second year, the network started a pay-per-view pilot project putting select NSIC Championship contests behind a paywall. The program's revenue would support the NSIC Championship experience and gain actual data for the league to review regarding pay-per-view events.












2025-26 NSIC ORGANIZATIONAL CHART
