- B. PSAC Officiating Committee Jay

- 4. **Shared costs for Field Hockey and Lacrosse:** A discussion was held regarding the possible equitable distribution of travel expenses for officiating for the sports of field hockey and lacrosse. Pros and Cons elaborated upon.

The conference office will work with the assignor to tighten travel expenses for member schools including a review of radius restrictions, ride sharing, and expansion of pool of officials

C. PSAC Championships/Competition Committee - Condino

Discussed the following items and made the following recommendations (where noted):

- 1. Reviewed draft document of Event Management Protocol Form developed by conference office and part of PSAC Strategic Plan Action Item 3.1.1. Athletics Administrators agreed that by the conclusion of the Summer 2012 each institution would complete the form for their basketball and football venues. A general plan for completion of the remaining venue reviews was also discussed.
- 2. Discussed contest start times and mandated league policies. Reviewed all league mandated start time policies with attention to institutional flexibility on scheduling.

MOTION (Condino) For the sport of Lacrosse, that mandated matches when teams play on consecutive dates start no earlier than noon and no later than 5:00 pm. SECOND (Richard)

4. Basketball Tournament Expansion Format. Discussed recommendations from the men's and women's basketball coaches regarding the format of a 12 team basketball tournament format in 2012-13 if approved by the Board of Directors in May of 2012.

MOTION (Condino): That for the sport of basketball, a 12-team championship tournament be conducted in the following format

Round 1: Saturday preceding the Championship game

#6 seed at #3 seed and #5 seed at #4 seed within the respective divisions of play Quarterfinals: Tuesday preceding the Championship game

#6/#3 winner at #2 seed and #5/#4 winner at #1 seed within the respective divisions of play. Semifinals: Friday preceding the Championship game at highest remaining seed on rotational basis between each division (Men-West in 2013; Women-East in 2013)

Semifinal format that would bracket #2 and #1 seeds from opposite divisions together Championship: Saturday featuring seeming winners SECOND (Heitzman)

  Encouraged ADs to participate in D2ADA, record high numbers have joined D2ADA. Reminded members to submit nominees to D2ADA Academic Awards program later in the year.
- F. Division II Nominating Committee Jude
  Discussed with the group the concern regarding the nomination and selection of individual for Sports
  Committees that may not have Regional Advisory Committee experience.
- G. PSAC Advisory Council Murray Reminded group that Bruce Baumgartner and Kelli Milliner represented the Athletics Administrators.
- V. New Business Conference Office
  - A. RefPay Services Last Fall a committee was establish of administrators to review the option of moving to RefPay for payment of officials and other documentation required for the 2012-13 fiscal year. RefPay is a service used in conjunction with Arbiter, a web-based officiating assigning service. For \$1.24 per official, institutions would set up payment accounts and automatically pay officials without the need of institutional services for check writing or 1099 documentation. Depending on institution and sports sponsorship it is estimated that total additional costs to an institution for this service would vary from \$125 to \$325 per institution.

MOTION (Wood): That beginning with the 2012-13 academic year, PSAC member institutions be required to participate in RefPay for payment of game officials in those sports which assign officials through Arbiter. The conference would participate in the format offered by RefPay that removes 1099 documentation from the member institutions (\$1.24/official).

A discussion was also held regarding feelers the NCAA has put out about adjusting start dates for football in future years to start earlier in those years the calendar shifts. The athletics administrators encouraged the conference office to support the earlier move....but a decision needs made soon.

- 3. Soccer Kauffman and McFarland
- a. Men's Soccer

MOTION (McFarland) If a sport is sponsored by 10-13 Members, its championship shall consist of a six-team playoff with no consolation games.

MOTION (McFarland) That for the sport of men's soccer, the PSAC championship field expand from 4 to 6 teams SECOND (Heitzman)

# Information Items approved for changes to Men's Soccer Operating Code:

#### Change #1

- 3. CHAMPIONSHIP PROCEDURES
- 3.1 TOURNAMENT FORMAT: The conference tournament shall consist of the four teams with the highest point total after in-season single round robin play. The team with the highest point total will be the #1 seed and the team with the second highest point total will be the #2 seed and so on through the #4 seed.
- 3.1.1 Seeding: A point system (3 points = win, 1 point = tie) shall be used to determine the play-off teams. The following criteria shall be used in order to break any tie(s) in the selection process for the conference tournament:
- a. Head to Head competition results between tied teams.
- b. Goal differential between tied teams in all mandated PSAC matches.
- c. Goals scored in all mandated PSAC matches.
- d. Record against teams not involved in a tie, starting at the top of the standings.
- e. Fewest goals allowed between tied teams.
- f. Away goals scored.
- g. Win-Lost record against common opponents outside the PSAC (non-PSAC opponents).
- h. A coin flip will occur to break ties between tied teams for PSAC playoffs after other tiebreakers have been used.

Change #2: In the event the conference regular season cannot be completed all contests must be rescheduled within 48 hours prior to start of PSAC Championship.

**Change #3:** If the mandated regular season contests cannot be completed, then the seeding for the conference tournament would revert to percentage of potential points earned based on games played. (i.e., Team A earns 22 points out of a possible 27 (nine games); Team B earns 21 points out of a possible 24 (eight games) – Team A has 81.4%, Team B has 87.5% -- with no rounding unless still tied; Team B would be a higher seed with less games played and less points.)

**Change #4:** In the event the Conference Championship cannot be completed, the highest remaining seed would advance as Champion.

#### b. Women's Soccer – No Report

# 4. Field Hockey – Wood

Note: A controversial item of eliminating divisional play and moving to an 14-match PSAC mandated schedule (11 countable and 3 extra pod matches) is already to be considered by the Board of Directors in May 2012. The following motions make adjustments to this original motion and clarify the options for scheduling:

MOTION (Wood): That in the sport of field hockey, to eliminate the East and West divisions, and play an 11-match round robin conference schedule beginning in Fall 2013.

**SECOND** (Kauffman)

MOTION (Wood) That in the sport of field hockey, the league standings and determination of the six teams qualifying for the PSAC championships be based on the 11 mandated games originally scheduled. SECOND (Kauffman)

# 5. Athletic Trainers - Gioglio

MOTION (Gioglio) That the PSAC mandate use of the Telvent/Weather Sentry only program for all member institutions beginning with the 2012-13 Fiscal Year. Further, that the conference provide funds towards the purchase of this program over the next three years with a 50%, 25% and 15% declining contribution from the league.

# 6. Wrestling – Baumgartner

champion points determined and a regular-season dual match championship for the 6 institutions sponsoring wrestling at the Division II level.
