Aetna does not have an Aetna-branded prescription drug plan (PDP) product for 2020, but our parent company, CVS Health*, offers SilverScript® PDPs that you can sell. Agents must complete SilverScript certification and contracting requirements prior to selling these products.

About SilverScript PDPs

SilverScript is one of the leading PDP providers in the country, serving over 6 million people with Medicare. They received an overall Star Rating of 3.5 Stars in 2019. In 2020, SilverScript is offering two PDP options across the US. Both plans are fully commissionable. Benefit highlights include:

- \$0 Tier 1 copays at preferred pharmacies
- Copays as low as \$1 on Tier 2 drugs

Overview of 2020 SilverScript PDPs

Two SilverScript PDPs, the Choice and Plus plans, will be available in all 50 states and in Washington, D.C. Members who selected the 2019 SilverScript Allure plan will be transitioned into the Choice plan.


