Our Mission

The National Title I Association is dedicated to improving and implementing the Title I program so that more children reach their academic potential. The Association provides educational leaders at the state and local levels with the opportunity to work together to share ideas on effective and innovative programs, identify problems and solutions, and represent the needs of Title I students and families.

Our Membership

The National Title I Association is a membership organization made up of Title I administrators and staff from the state and local levels, charged with managing programs under Title I of the Elementary and Secondary Education Act (ESEA). They ensure compliance with federal regulations, but more importantly work to see that all children — especially those living in economically disadvantaged conditions — have the opportunity to receive a high quality education.

Our Programs

The National Title I Association provides a range of information and professional development services to its members and to the Title I Community at large. Revenue from membership dues, conference registrations, sponsorships, and video subscriptions all contribute to the overall budget that allows the Association to operate.

Government Relations

National Title I Distinguished Schools

Since 1996, the Association has annually honored up to two Title I schools per state for exemplary progress. Schools qualify under one of two categories:

 Exceptional Student Performance for Two or More Years Closing the Achievmeent Gap Between Student Groups.

With hundreds of options covering a range of Title I-pertinent topics, this online video-based professional development programming is an always-available solution for group learning environments.

National Title I Conference

Held in late January or early February in various locations, this major annual event provides professional development opportunities for thousands of Title I practitioners at all levels.

Collaboration with Other Organizations

Working together with other education associations, the National Title I Association undertakes a wide range of projects focused on the needs of Title I students. Recent examples include a technology toolkit for school staff in partnership with CoSN and literacy intervention activities as part of summer meal programs in cooperation with ILA.

Membership Categories

All membership categories require payment of annual dues and provide an active membership for one individual representing their local or state agency for a period of 365 days. Memberships "belong" to the agency and may be transferred to another authorized individual at no cost during the active period, as necessary to accommodate staffing changes.

Active Members \$299

Each state may have two SEA-selected Active Members who work in or supervise the Title I program at the state level. The first is most often the State Title I Director and the second may be any other SEA staff with direct Title I program supervision.
