

How Tejas Finance shares your personal information

Why am I getting this document?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What information does Tejas Finance share?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number and income
- Credit score and credit history
- Account balance and payment history

When you are no longer our customer, we continue to share your information as described in this notice.

How does Tejas Finance share my information

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their Customers' personal information; the reasons Tejas Finance chooses to share; and whether you can limit this sharing.

What we do

HOW DOES TEJAS FINANCE PROTECT MY PERSONAL INFORMATION?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

WHAT HAPPENS WHEN I LIMIT SHARING FOR AN ACCOUNT I HOLD JOINTLY WITH SOMEONE ELSE?	Your choices will apply to everyone on the account.

Definitions

AFFILIATES	Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include Tejas Finance
NON-AFFILIATES	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Tejas Finance does not share with non-affiliates so they can market to you.
JOINT MARKETING	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Tejas Finance does not jointly market.

Other Important Information

CA and VT Residents: We will not share your information with companies outside of Tejas Finance except for our everyday business purposes, for marketing our products and services to you, or with your consent.

VT Residents only: We will not disclose credit information about you within or outside Tejas Finance family of companies except as required or permitted by law.
