85 Cross St: Applicant & Owner Wilfredo Canenguez, Agent, Richard DiGirolamo, Esq. sought a Special Permit with Site Plan Review to create two principle structures (SZO §7.2) and two variances (SZO §8.5.H) minimum side yard setback, (SZO §8.5.I) minimum rear yard setback to convert an existing rear garage to one dwelling unit. RB zone. *The Applicant requested to Withdraw the Petition Without Prejudice. <u>52 Park St</u>: Applicant & Owner, Charles Morton seeks a special permit (SZO §4.4.1) to build a dormer and a 320 S.F. addition on an existing three-family dwelling. <u>**0** R Rutherford Ave:</u> Applicant & Owner, KTI Recycling of New England, Inc. dba FCR Boston.
