July: Final design development begins based on June feedback

August: 75% plans are completed and including in construction bid package


October: 100% plans are completed and given to awarded contractor

Spring 2023: Street construction contract begins

State Highway and MassDOT Project Updates

Lead: City of Somerville

- Mystic and Shore Dr. Intersection Reconstruction
 - Finalizing design
 - Coordinating with MassDOT and Eversource on construction logistics
 - Planned construction in 2022
- Mystic and Middlesex Intersection Reconstruction
 - Developing 25% design
- Mystic Ave. Peak Hour Bus Lane Pilot
 - Analyzing traffic and air quality data
 - Coordinating with MassDOT, MBTA, Medford on next steps for pilot bus lanes

Lead: MassDOT

- Route 28/38 Intersections Early Action Projects
 - Designs complete for raised crossings and ADA improvements
 - Planned construction in 2022
- Route 28/38 Intersection Project
 - MassDOT developing revised 25% design
 - Construction start aimed for 2023/24
- McGrath Resurfacing Project
 - Design complete
 - Planned construction in 2022
- McGrath Boulevard Project
 - MassDOT developing 25% design
 - MassDOT and City coordinating to secure federal construction funding

Pedestrian Safety Training


- Vision Zero Action: Hold Pedestrian
 Safety Training for every 2nd grader
- Partnership between SPS, Office of Food Access and Healthy Communities, MassDOT's "Safe Routes to School" Program, and Mobility Division
- Trained ~350 second graders in SPS over the past few weeks




Vision Zero Updates






2021 Vision Zero Annual Report

Vision Zero is the City's plan to end traffic fatalities and severe injuries on our streets.

With the Vision Zero policy adopted in 2017, and the Action Plan finalized in 2020, this is the City's second annual report on the progress of Vision Zero in Somerville.

Why is Vision Zero important?

- Motor vehicle crashes are a leading cause of death nationally. Each year, more than 40,000 people are killed on U.S. streets and thousands more are injured.
- In 2021, more people died on
 Massachusetts roads than in any year since
 2009
- In Somerville, crashes have trended downward over the past decade, but we had several fatalities in 2019 and 2020.

The City is taking action to reverse these trends, make our streets safer for everyone, and advance our Vision Zero goals.

This report summarizes major vision zero accomplishments in 2021 and the City's plans for the future.


