Pursuant the Somerville Planning Board's Rules of Procedure & Policy, commercial signs require only Minor Site Plan Approval, with the Director of Planning, Preservation, & Zoning serving as the decision-making authority in-lieu of the Planning Board.

This decision summarizes the findings made by the Director of Planning, Preservation, & Zoning regarding the development review application submitted for 385 Broadway.

SUMMARY OF PROPOSAL

Applicant ArtDesigns LLC proposes to install one (1) wall sign at 385 Broadway in the Commercial Business District, as permitted under and compliant with Section 10.8.12). The wall sign will read "The Hair Garden" and complies with Somerville Zoning Ordinance as it relates to commercial wall signs, specifically section 10.8.12.

On October 31, 2022, the Director of Planning, Preservation, & Zoning reviewed the submitted application materials.

FINDINGS

In accordance with the Somerville Zoning Ordinance and the Planning Board's Rules of Procedure and Policies for minor site plan approvals, the Director of Planning, Preservation, & Zoning may approve or deny a site plan approval upon making findings considering, at least, each of the following:

P&Z 22-133 385 Broadway

1. The comprehensive plan and existing policy plans and standards established by the City.

The Director finds that this proposal is consistent with the values of SomerVision 2040. the City's Comprehensive Master Plan, including, but not limited to, supporting commercial development.

2. The intent of the zoning district where the property is located.

The Director finds that the proposed signage is consistent with the intent of the Commercial Business (CB) District, which is, in part, "[t]o maintain commercial activities that are primarily accessed by motor vehicles."

3. Mitigation proposed to alleviate any impacts attributable to the proposed development.

The Director finds that the proposed commercial signage does not cause any impacts deserving of mitigation.

DECISION

Following review of the submitted application materials and the statutorily required considerations, the Director of Planning, Preservation, & Zoning APPROVED the Site Plan Approval authorizing one commercial wall sign on behalf of the Planning Board.

Any appeal of this decision must be filed within twenty days after the date this notice is filed in the Office of the City Clerk, and must be filed in accordance with M.G.L. c. 40A, sec. 17 and SZO sec. 15.5.3.

In accordance with M.G.L. c. 40 A, sec. 11, no variance shall take effect until a copy of the decision bearing the certification of the City Clerk that twenty days have elapsed after the decision has been filed in the Office of the City Clerk and no appeal has been filed, or that if such appeal has been filed, that it has been dismissed or denied, is recorded in the Middlesex County Registry of Deeds and indexed in the grantor index under the name of the owner of record or is recorded and noted on the owner's certificate of title.

Also in accordance with M.G.L. c. 40 A, sec. 11, a special permit shall not take effect until a copy of the decision bearing the certification of the City Clerk that twenty days have elapsed after the decision has been filed in the Office of the City Clerk and either that no appeal has been filed or the appeal has been filed within such time, is recorded in the Middlesex County Registry of Deeds and indexed in the grantor index under the name of the owner of record or is recorded and noted on the owner's certificate of title. The person exercising rights under a duly appealed Special Permit does so at risk that a court will reverse the permit and that any construction performed under the permit may be ordered undone.

The owner or applicant shall pay the fee for recording or registering. Furthermore, a permit from the Division of Inspectional Services shall be required in order to proceed with any project favorably decided upon by this decision, and upon request, the Applicant shall present evidence to the Building Official that this decision is properly recorded.
