CALL TO ORDER

President Van Sleet called the meeting of the Library Board of Trustees to order at 6:04 pm.

MINUTES

Ami Feldman motioned to approve the minutes from the November 9, 2022, meeting; Lamia Mamoon seconded, and the minutes were approved.

DIRECTOR'S REPORT

- 1. MBLC construction grant: Continuing to review new guidelines and to plan for submitting a grant application.
- 2. Professional development for staff: A full day of on-site professional development is scheduled for January 20. Exploring potential speakers on topics of wellness and self-care. The Foundation is providing lunch.
- 3. State aid: Somerville qualified for state aid and the check has arrived.
- 4. West Branch renovation: The <u>West Branch renovation</u> was awarded a prestigious <u>2022 American</u> Architecture Award.
- 5. Public health vending machines: Chief of Staff Nikki Spenser asked if the libraries would be interested in participating in a pilot project proposed by Councilor Kristen Strezo to make public health vending machines from the vendor, <u>SOS</u>, available. There is interest, but also a need to review privacy issues associated with the machines.
- 6. Social Media Policy: Trustees reviewed the draft policy. Comments and suggestions will be incorporated in a new draft for a vote at the next meeting.

PRESIDENT'S REPORT

1. Somerville Public Library Foundation Update: The Board is complete. Foundation continues to work on the early literacy initiative and look for opportunities to fund.

- 2. Board of Trustees membership: We welcomed potential Trustee Mike Smith who is awaiting confirmation as the newest Board member. When he is confirmed, the Board of Trustees will have a full Board.
- 3. Google Drive: Trustees present confirmed they could access the shared Google Drive containing Trustee documents.
- 4. MBLC grant advocacy: Subcommittee for MBLC grant advocacy will be established in the new year.
- 5. By-Laws: Revised By-Laws provided by the Archives Committee will be reviewed at next meeting.

COMMITTEES

Archives Committee: Janaki Perera joined the committee. The committee presented the revised By-Laws for review and continues to work on organizing documentation and updating the Trustee page on the SPL website.
