COMMUNICATIONS

- 1. Minutes of the Regular Licensing Commission Meeting of 1/23/23

 The Commission approved the minutes by a roll call vote of 2 in favor (Lynch & Thomas), 1 absent (Allen) and 0 opposed.
- 2. Communication from Chair Lynch: That the SLC discuss the Licensing Commission fees associated with Adult Use Recreational Marijuana (application fee and renewal fee) Continued from the 10/17/22 and 1/23/23 Licensing Commission Meeting Chair Lynch stated the administration is not ready to make a recommendation on this matter and it will be addressed at a future meeting. This item was placed on file.



3. Commissioner Allen conveying proposed changes to the Rules and Regulations of the Licensing Commission:1.18 Extension of Premises to Patio and Outdoor Area's:

h. The permit for patio seating in the public way will be seasonal, from April 1st to no later than November 30th. All tables, chairs, and accessories used in the outdoor seating area must be removed during all other time periods. This restriction is not applicable to private patio seating permits. The dates of use for each establishment may be reviewed and reduced by the Licensing Commission for any reason.

Chair Lynch stated he believes this can be done for the March meeting and will seek Director Postlewaite's approval. Commissioner Allen stated this language is for public seating only. A discussion was held about public street and parklet seating and how to define them. Chair Lynch also stated there may be emergency reasons why a private patio would need to remove patio furniture.

The Commission continued this item until the March 20, 2023 Licensing Commission Meeting.

- 4. Communication from the City Clerk conveying proposed changes to the Rules and Regulations of the Licensing Commission based upon the administration's Outdoor Seating Proposal: 1.18 Extension of Premises to Patio and Outdoor Area's:
 h. The permit for service of alcoholic beverages at outdoor seating will be seasonal, from April 1st through no later than November 30th. All tables, chairs and accessories used in the outdoor seating area must be removed during all other time periods. The date
 - from April 1st through no later than November 30th. All tables, chairs and accessories used in the outdoor seating area must be removed during all other time periods. The dates of use for each establishment may be reviewed and reduced by the Licensing Commission for any reason.
 - i. Any violation of these rules and regulations may result in fines, suspension and revocation of the license, and other punitive actions as determined by the Licensing Commission.
 - j. Licenses are not transferable.
 - k. For Public Street Seating only:
 - (1) Licensee shall provide & maintain trash receptacle and/or provide bussing service during all hours of operation.
 - (2) Licensee shall post a conspicuous sign requiring patrons to not rearrange seating or relocate seating into the sidewalk or other *accessible* walks, routes, ramps or aisles.
 - (3) Licensee's operation in the licensed area may not begin earlier than 6:00 AM and may not extend beyond Midnight (12:00AM), inclusive of time to setup, breakdown and clean the area. Operation must not exceed the hours of the master license.
 - (4) Licensed areas in the public street shall only be authorized from April 1 to November 30. All seats, tables, barriers, signs, stands, etc. shall be removed from the public street by December 1.
 - (5) Parklet Seating shall include reflective tape or reflective markers to the traffic facing sides of the Parklet structure or railings.
 - (6) Parklet Seating platforms and other temporary structures shall include removable sections to access all utility manholes and access structures. Licensee shall remove



sections when requested by City. At least 24 hours verbal notice will be provided. Emergencies may require shorter or immediate notification.

- (7) Parklet Seating platforms and other temporary structures shall maintain a clear drainage path beneath the structure. Licensee shall clean beneath the structures on a monthly basis to clear debris and blockages from the drainage path.
- 1. For Dog Areas only:

- (1) Licensees shall prohibit animals, except service animals, from all outdoor seating areas unless their license explicitly allows dogs in such areas.
- (2) Licensees with a license that allows dogs shall ensure that every dog in the outdoor seating area is licensed and leashed, shall prohibit employees from touching or handling dogs, and shall provide bowls of water for the sole use of dogs.
- (3) Licensees with a license that allows dogs shall post a conspicuous sign to designate the outdoor dog area, and to prohibit dogs from sitting or standing on any furniture and from eating anything, including scraps, from plates, drinkware, or utensils. Dogs may not be seated on the laps of patrons at any time.

5. Communication from Chair Lynch recommending a Change to the Rules and Regulations for Outdoor Seating, to require a Newspaper AD for All Outdoor Seating, due to recent changes to the Outdoor Seating Rules & Regulations.

Continued from the 1/23/23 Licensing Commission Meeting

Chair Lynch stated this item was continued from the January 23, 2023 meeting in order for Commissioner Allen to weigh in on the matter. A discussion was held on how newspaper postings are the legal requirement for public hearing notices. Chair Lynch stated that during COVID, outdoor seating did not require a public hearing. Commissioner Allen stated an advertisement and a notice in the storefront would be appropriate. Commissioner Thomas is against the cost of an advertisement being placed in the newspaper and stated this is not the most effective way to notify residents. Assistant City Clerk Bernabe Rodriguez reminded the Commission of the Open Meeting Law legal requirement and that the advertisement is the notice for the public

Raphael Alvez appeared for this application. He shared that there will be approximately 500-2000 people, and wrist bands and security will be used. Mr. Alvez stated there were 8 detail officers last year and will consult with the Police Department about the need for details. Fire Captain Bakey asked if there would be propane tanks used and Mr. Alvez stated there would be. He was instructed to contact the Fire Department to determine if a permit is necessary.
