Chair Lynch acknowledged this license is in the process of being sold.

4. Communication from Chair Lynch to amend Section 5.04 of the Somerville Licensing Commission Rules and Regulations - Additional Rules for Marijuana Establishments, to read: a. Marijuana retailers may operate no earlier than 9 AM and no later than 11 PM Monday through Saturday, and no earlier than 10 AM and no later than 11 PM on Sunday.

Chair Lynch stated that Retail Marijuana establishments have been open in the City of Somerville and no complaints have been received from the Police Department, the City Administration or from the City Councilors in these wards. Chair Lynch reached out to several Councilors, and received no objections to this change. Commissioner Allen asked about the hours of operation in neighboring municipalities. Chair Lynch indicated most municipalities currently have hours of operation until 11pm and a few are open until 12am. Chair Lynch reminded the Commissioners should any issues arise, they have the authority to bring the licensee in and to roll back the hours of operation.

The Commission approved this change to the Somerville Licensing Commission Rules and Regulations.

#### SPECIAL ALCOHOL LICENSES

5. The Portuguese-American Civic League, 26 Springfield St., requesting approval of a Special Alcohol License for the American Holy Ghost Fest to be held Indoors and Outdoors at 26 Springfield St. and in the Parking Lot on Friday, July 7, 2023, Saturday, July 8, 2023, and Sunday, July 9, 2023 from 7:00pm-12:00am (Alcohol Service) (PEL23-000083)

Vasco Cunha, Director, and Joe Vasconcelos, Treasurer, appeared for this application. Mr. Vasconcelos requested an amendment to this application to serve alcohol at 12pm on Sunday. Identification will be checked at the point of sale to purchase alcohol. Police and Fire details will be requested from the City of Somerville and a detail will be requested from the City of Cambridge. Americans with Disabilities Act (ADA) compliant toilet facilities will be provided. The noise ordinances for the City of Somerville and the City of Cambridge will be observed and the music volume will be lowered at approximately 10pm or 10:30pm. Neighbors will be notified of this event. Signs will state no alcohol beyond this point. Captain Otting suggested the applicant work with the Fire Department regarding tents more than 10 feet by 10 feet and for flammables permits. Mr. Vasconcelos



indicated BC Tent and Awning Co., Inc. will be contacting the Fire Department for the tent permit.

The Commission approved this Special Alcohol License.

6. Revival Davis LLC, 197 Elm St., requesting approval of a Special Alcohol License for a Sarma Picnic Party by Liz Barwick to be held Indoors in the Café and Outdoors on the private patio at 197 Elm St on Sunday, July 9, 2023, from 5:00pm–8:00pm (Alcohol Service) (PEL23-000086)

Commissioner Allen assumed the Chair.

Jillianne Quinn, Finance and Administration Manager, appeared for this application. Ms. Quinn declared this is the second pop-up event to be held with this chef. All servers will be TIPS Certified and the location is ADA accessible. Ms. Quinn stated they expect approximately 75 to 80 participants, and no prior violations were reported. Craft Collective will be the purveyor for the wine and malt for this event and wristbands will be provided for identification purposes. The alcohol service area will be cordoned off.

The Commission approved this Special Alcohol License.

7. The Center for Arts at the Armory, 191 Highland Ave., requesting approval of a Special Alcohol License for Bar Stars to be held Outdoors on the Roof of Block 3 Garage at Assembly Row on Thursday, July 13, 2023, from 6:00pm–9:00pm (Alcohol Service) with a Rain Date of 7/20/23 (PEL23-000088)

Commissioner Allen assumed the Chair.

Stephanie Scherpf, Co-Director and CEO and Haley King, Marketing Manager, from Federal Reality Investment Trust appeared for this application. Ms. Scherpf stated this will be a ticketed event, identification will be required at the door and wristbands will be provided. Food and drink samples will be provided by various restaurants in Assembly Row. Approximately 500 participants are expected to be in attendance. Servers will be TIPS Certified. Ms. King indicated she would be contacting the Police and Fire Departments to ascertain if details are required. Captain Otting clarified that this event is not being held in an approved assembly occupancy area and a Fire Department detail will



be required. Chair Lynch requested a description of any other not for profit agencies to hold this event in the past. Ms. King confirmed the Somerville Media Center was the charity partner for this event last year. There were 500 attendees last year with a Police Department detail. Ms. King indicated no response was received from the Fire Department for a detail last year. Assembly Row provides security personnel for this event.

The Commission approved this Special Alcohol License.

8. Downeast Cider House LLC, 256 Marginal St. Boston, requesting approval of a Special Alcohol License for Downeast @ Volo to be held Outdoors in the open lot adjacent to Foley St. and Assembly Row from June 6, 2023, to July 5, 2023, from 12:00pm–10:00pm (Alcohol Service)

Commissioner Allen assumed the Chair.

Brad Tinkham, Director, appeared for this application. Mr. Tinkham explained they will be working with Volo in the Assembly Row area. The area contains 4 volleyball courts and 9 football courts and a cider garden with picnic tables adjoining the green space will be utilized. All staff will be TIPS Certified and will have crowd management training. Bathrooms will be provided by Volo and the area will be fenced in. Commissioner Allen asked if there had been any issues during the past month of operation. Mr. Tinkham responded that the bar has not opened yet due to an electrical requirement and hopes to have this resolved and open by the weekend.

The Commission approved this Special Alcohol License.

Commissioner Allen assumed the Chair.



JJ Gonson, Owner, appeared for this application. Ms. Gonson specified these events will be sponsored by the Boynton Yards development in the parking lot. This will be the third summer for holding these events with 2 events scheduled for this summer. Wristbands will be used. The parking lot being used is adjacent to the one used previously. No complaints or issues were reported last year.

The Commission approved this Special Alcohol License.

The Chair opened the public hearing at 6:29pm.

There being no speakers, the Chair closed the public hearing at 6:30pm.

Chair Lynch stated that Councilor McLaughlin, the Ward Councilor for this location, had no objections to this application.

The Commission approved this Public Sidewalk Seating License.

James Harrison, President, appeared for this application. Mr. Harrison stated they previously had outdoor seating and it was very successful. He also mentioned the outdoor seating helped to employ 4 additional people. Commissioner Thomas asked about the Americans with Disabilities Act (ADA) accessibility apparatus they had outdoors. Mr. Harrison explained that they have a picnic table designed to the required ADA accessibility specifications and that they had the correct bathroom calculations for Public Parklet Seating. Chair Lynch inquired from Captain Otting if all concerns were addressed for the Public Parklet Seating for the small streets off Elm St. Captain Otting replied that they continue to work with each applicant and make minor adjustments as necessary. There were no access concerns for these floor plans as submitted. Engineer De Moura Maia stated she had worked with Mr. Harrison and all the required improvements were submitted. She recommended approval.

The Chair opened the public hearing at 6:35pm.

There being no speakers, the Chair closed the public hearing at 6:35pm.

The Commission approved this Public Parklet Seating License.

12. Barra Bars LLC d/b/a Barra, 23A Bow St., requesting approval of a Public Parklet Seating License

Outdoor Public Parklet Seats: 26 (ALM23-000050)

Paola Ibarra, General Director and Co-Owner, appeared for this application. Ms. Ibarra stated this is the same seating as last year with ADA accessible seating and ADA compliance in place and they have an ADA accessible bathroom. Commissioner Allen asked about future access to the courtyard. Ms. Ibarra informed the commission that this area is not ADA compliant and will not be used. Engineer De Moura Maia declared that the plans were revised as required and recommended approval.

The Chair opened the public hearing at 6:38pm.

Dan Luft, an employee of the building which abuts the area behind Barra, spoke on this matter and expressed concerns about the future use of the courtyard, the closeness of the 6



porches that abut this area and indicated when there was seating in this area, the tenants had issues with the lights, noises and smells.

Chair Lynch made clear this application had nothing to do with private patio seating and the Commission would only address the application before them.

Sheila Foley, Owner of The Neighborhood Restaurant, spoke on this matter and also expressed concern about private patio seating.

Chair Lynch reiterated this application had nothing to do with private patio seating and the Commission would only address the application before them.

The Chair closed the public hearing at 6:42pm.

The Commission approved this Public Parklet Seating License.

Ms. Rondeau stated she was approved for both Public Parklet Seating and Private Patio Seating at a previous Licensing Commission Meeting but would like to change this to Public Parklet Seating only. Engineer De Moura Maia stated the seats are being moved from the Private Patio to the Public Parklet and recommended approval.

The Chair opened the public hearing at 6:44pm.

There being no speakers, the Chair closed the public hearing at 6:44pm.

Sean Olson, Owner, appeared for this application. Mr. Olson stated they were previously approved for 65 Private Patio Seats and were using approximately 45 seats inside the pavilion. They are currently in the process of increasing the size of the pavilion to include 64 seats. Commissioner Allen asked for some clarification on the pavilion. Mr. Olson declared that this is a post and beam structure, able to withstand winds up to 110 mile per hour and will be bigger by approximately 16 feet by 16 feet. The pavilion will have roll up sides and 6 ADA accessible seats. Chair Lynch asked if there were any outdoor heaters. Mr. Olson confirmed they currently have small electric heaters and hope to update these to permanent heaters. They are currently in the process of completing the permanent electrical heaters with an electrician. Chair Lynch asked if he had Fire Department approval for any type of heaters. Mr. Olson confirmed he did not have Fire Department approval and will discontinue the use of heaters until he consults with the FireDepartment. Chair Lynch instructed Mr. Olson to apply for an amendment to this license for the heaters. Engineer De Moura Maia informed the Commission that the Private Patio Seating is on Canal St. She also indicated the floor plans indicate 6 feet clearance for pedestrians, but the measurements approved were 4 feet 6 inches for pedestrian clearance, and she instructed the applicant that new floor plans must be submitted. Engineer De Moura Maia recommended approval of this license with the submission of a new floor plan and confirmed this seating is on a private way. Captain Otting informed the Commission that both the Inspectional Services Division and the Fire Department will require a review of the power supply and the type of heaters. This information can be added to the existing floor plans and will require submission to the Inspectional Services Department and the Fire Prevention Bureau.

The Chair opened the public hearing at 6:53pm. There being no speakers, the Chair closed the public hearing at 6:53pm.

The Commission approved this Private Patio Seating License.
