### **SPECIAL ALCOHOL LICENSES**

4. Somerville Education Foundation, 18 Hamilton Rd., requesting approval of a Special Alcohol License for the purpose of dispensing and/or selling alcoholic beverages for a Taste of Somerville to be held Outdoors at Baxter Park on Wednesday, June 14, 2023, from 5pm–8pm with a Rain Date of 6/15/23 (Alcohol Service) (PEL23-000080)

Greg Nadeau, President of the Somerville Education Foundation, and Steve Mackey, Somerville Chamber of Commerce, appeared for this application. Mr. Mackey described the food and alcohol to be served for this annual event for 1,000 people. The event will be surrounded by a fence with a VIP and general admission gate staffed by a Police detail, event security and ticket takers. Over-21 bracelets will be used, and alcohol will be served in a separate enclosed area. Chair Lynch asked if written permission had been received for this park, as it is Department of Conservation and Recreation (DCR) property. Mr. Mackey stated the DCR permit is pending for the Somerville Education Foundation. Chair Lynch requested a copy of that permit be sent to the Licensing Commission. Chair Lynch reminded Mr. Nadeau and Mr. Mackey that all servers must be TIPS Certified and suggested carding individuals if unsure of their age. Commissioner Thomas asked if propane tanks will be used, and Mr. Mackey confirmed a Flammables License request has been submitted to the Somerville Fire Department and is pending. Chair Lynch asked for confirmation that Baxter State Park is Americans with Disabilities Act (ADA) accessible, and Mr. Mackey confirmed that it is. Chair Lynch requested Acting Captain Otting apprise Captain Bakey of the imminent Flammables License request. Captain Otting confirmed that the request would be reviewed promptly, and the Fire Department will work with other city departments in a coordinated effort. Mr. Mackey informed the Commission that the Massachusetts Department of Public Health will permit the tents and they are working in collaboration with the Somerville Fire Department. Chair Lynch advised copies of anything received from the State of Massachusetts be sent to the Licensing Commission, the Police Department, and the Fire Department.

Felipe Nonato appeared for this application. Mr. Nonato stated this is the same number of seats as in previous years. He also informed the Commission that no issues were reported last year. A bathroom will be shared with the business next door and proper signage will be posted. Brian Postlewaite, Director of Engineering, stated he reviewed the toilet seat count, and recommended approval.

The Chair opened the public hearing at 6:31pm.

There being no speakers, the Chair closed the public hearing at 6:32pm.

Courtney Verhaalen appeared for this application. Ms. Verhaalen stated the parklet is located directly next to the curb with no more than ¼ inch of lip space. It is also 25% ADA accessible with a bridge plate to assist wheelchairs. A Jersey barrier will be employed on the traffic-facing side with reflective strips. Captain Otting clarified for all applicants that Chief Breen has expressed concern that fire apparatus may be unable to deploy stabilizers in congested areas with parklet seating on both sides of the street, and she noted approvals may be issued with conditions to allow for modifications needed. Chair Lynch advised Director Postlewaite to discuss this concern with the Fire Department. He also stated all outdoor licensees understand any city department has authority to move this dining in the case of an emergency. Director Postlewaite informed the Commission that the



Inspectional Services Division conducts field inspections prior to outdoor seating opening and will discuss this matter with the Fire Chief and make any adjustments necessary. Director Postlewaite recommended approval.

The Chair opened the public hearing at 6:42pm.

Chair Lynch asked if landlord approval was received. Ms. Venezia confirmed that it was. Commissioner Thomas advised Ms. Venezia to be mindful of sanitation in the area. Director Postlewaite recommended approval.

Jose Martinez, Manager, appeared for this application. Mr. Martinez stated the previous owner had outdoor seating last year and did not know of any problems. The Jersey barrier has remained from last year. Chair Lynch reminded Mr. Martinez that the establishment is in a densely packed neighborhood and to be mindful of noise levels especially at night. Director Postlewaite noted this establishment has private seating, which is immediately adjacent to the sidewalk, but reiterated that it is private seating. Director Postlewaite recommended approval.

The Chair opened the public hearing at 7:07pm.

Dylan Welsh, Owner, appeared for this application. Mr. Welsh confirmed this is the same seating as the last three years, is ADA compliant, has a ramp and reported no issues. Director Postlewaite informed the Commission this parklet is directly across from the Diesel Café and Foundry on Elm parklets. He noted these parklets are raised but Elm Street Taproom's parklet isn't and this may allow some flexibility. He will work with the Fire Department to ensure safe operation in case of an emergency. Approval conditions will be implemented due to Elm St. and Holland St. sidewalk construction work scheduled for this summer and possibly next. Licensees will be notified at least two weeks in advance. Director Postlewaite recommended approval.

Rob Gregory appeared for this application. Mr. Gregory stated they reduced the seating from 40 seats to 38 seats based on their bathroom calculations and will have two, four-seat tables which will be ADA accessible. Acting Captain Otting will follow up with the applicant to ensure an application has been submitted for the propane heaters. Commissioner Thomas stated the area is tight and asked about considerations for emergency vehicles and if there were any problems reported last year. Mr. Gregory stated he is unaware of any issues. Commissioner Thomas asked Director Postlewaite about a follow-up notation from last year for emergency apparatus. Director Postlewaite informed the Commission that this was an issue with the adjacent parklet, and no concerns were raised from any tests for apparatus going down Chester St. Chair Lynch clarified there were issues with the corner placement of some of the outdoor seating and these seating areas were requested to move from the corner, and the width of Mr. Gregory's parklet was reduced due to Fire Department concerns. Captain Otting commented that they need to ensure both the turning radius and the width of clearance that would allow the Fire Department to safely deploy the stabilizers on any ladder truck or tower ladder truck and they can work with the applicants on this. Director Postlewaite indicated that if a nonsubstantial change is necessary for any of these licenses, plans will be updated by Engineering, because Engineering will not be in attendance for subsequent deployments of outdoor seating as these are permanent licenses. He recommended approval.

Director Postlewaite brought to the Commission's attention that this applicant was approved by the Board of Health for a variance for this calendar year only and will need to revise or amend this sidewalk seating next year once an acceptable solution has been made to meet the full criteria of the building code. He recommended approval. Chair Lynch stated that the Board of Health has the authority to issue a variance for the bathroom requirements for restaurants.
