This decision summarizes the findings made by the Zoning Board of Appeals (the "Board") regarding the Special Permit Finding application submitted for 118 Rogers Avenue.

#### **LEGAL NOTICE**

Valerie Humblet seeks to further extend the existing nonconformity for the required rear setback in the Neighborhood Residence (NR) district, which requires a Special Permit Finding.

# **RECORD OF PROCEEDINGS**

On July 19, 2023, the Zoning Board of Appeals held a public hearing advertised in accordance with M.G.L. 40A and the Somerville Zoning Ordinance. Present and sitting at the public hearing were Board Members Chair Susan Fontano, Vice-Chair Anne Brockelman, Clerk Katherine Garavaglia, Zachary Zaremba, Alternate Brian Cook, and Alternate Sisia Daglian. The Applicant described their request, and PPZ Staff reviewed the requirement for a Special Permit. One member of the public spoke in support of the application. Following public testimony, the Board discussed the application and moved to vote on the matter.

## SPECIAL PERMIT FINDING

In accordance with the Somerville Zoning Ordinance and M.G.L. Chapter 40A, Section 6, the Zoning Board of Appeals may grant a Special Permit Finding only upon deliberating and finding the following at the public hearing:

• Pursuant to M.G.L. Chapter 40A, Section 6, "pre-existing nonconforming structures or uses may be extended or altered, provided, that no such extension or alteration shall be permitted unless there is a finding by the permit granting authority or by the special permit granting authority designated by ordinance or by-law that such change extension or alteration shall not be substantially more detrimental than the existing nonconforming use to the neighborhood".

The Zoning Board of Appeals finds that the proposed extension is not substantially more detrimental than the existing nonconforming structure to the neighborhood.

# **DECISION**

Following public testimony, review of the submitted plans, and discussion of the statutorily required considerations, Clerk Garavaglia moved to approve the **Special Permit Finding** to further extend the existing nonconformity for the required rear setback with the conditions included in the subject Staff Memo for the application dated July 11, 2023. Zaremba seconded. The Board voted **5-0** to approve the permit, subject to the following conditions:

Prior to Building Permit

- 1. This Decision must be recorded with the Middlesex South Registry of Deeds.
- 2. A digital copy of the recorded Decision stamped by the Middlesex South Registry of Deeds must be submitted to the Planning, Preservation, & Zoning Division for the public record.

## **CLERK'S CERTIFICATE**

Any appeal of this decision must be filed within twenty days after the date this notice is filed in the Office of the City Clerk, and must be filed in accordance with M.G.L. c. 40A, sec. 17 and SZO sec. 15.5.3.

In accordance with M.G.L. c. 40 A, sec. 11, no variance shall take effect until a copy of the decision bearing the certification of the City Clerk that twenty days have elapsed after the decision has been filed in the Office of the City Clerk and no appeal has been filed, or that if such appeal has been filed, that it has been dismissed or denied, is recorded in the Middlesex County Registry of Deeds and indexed in the grantor index under the name of the owner of record or is recorded and noted on the owner's certificate of title.

Also in accordance with M.G.L. c. 40 A, sec. 11, a special permit shall not take effect until a copy of the decision bearing the certification of the City Clerk that twenty days have elapsed after the decision has been filed in the Office of the City Clerk and either that no appeal has been filed or the appeal has been filed within such time, is recorded in the Middlesex County Registry of Deeds and indexed in the grantor index under the name of the owner of record or is recorded and noted on the owner's certificate of title. The person exercising rights under a duly appealed Special Permit does so at risk that a court will reverse the permit and that any construction performed under the permit may be ordered undone.

The owner or applicant shall pay the fee for recording or registering. Furthermore, a permit from the Division of Inspectional Services shall be required in order to proceed with any project favorably decided upon by this decision, and upon request, the Applicant shall present evidence to the Building Official that this decision is properly recorded.
