On 4/29/2021 attorney Feeney submitted a pre-hearing Letter to DALA stating the Somerville Retirement Board has no position and will let PERAC argue the case. Received 5/7/2021 DALA Decision. CRAB issued a Review Order for the case. On 6/23/2021 PERAC submitted a Memo to CRAB requesting CRAB reverse the 5/2021 DALA decision. On 3/7/2022 received DALA Notice of Receipt of Appeal (CR-22-0095) for W. White Anti-Spiking appeal. Attorney Feeney requested motion to expedite review in order to join W. White with the other Anti-Spiking case with CRAB. DALA Magistrate Rooney granted motion to expedite (agreed to by Mr. White). The motion to join PERAC as a necessary party was allowed. Attorney Feeney requested joint brief summary decision. Received DALA Order To Show Cause on 8/2/2022 for W. White. On 9/8/2022 received DALA Decision, reversing Board's decision. PERAC appealed to CRAB. On 11/16/2023 received CRAB decisions for W. White & R. Willette & M. Heuston, affirming the DALA decision, Anti-Spiking provisions of Ch. 32 Sect. 5(2)(f) do not apply, the salary increase received can be included in regular compensation. PERAC will Not appeal this decision. The Director will notify the 3 retirees (and provide a copy of the CRAB decision) and have the Deputy Director begin recalculating their new monthly retirement allowance and retroactive amount in December.
