Item #1 – Acceptance of the Minutes from the May 23, 2024 Traffic Commission Meeting.

Item #2 – Request to remove one resident permit parking space in front of 45 Marshall Street to implement a new crosswalk across Marshall Street at Mortimer Place. The crosswalk will enhance the pedestrian route for students and families walking from the Edgerly Education Center to the Winter Hill Community School. This will also provide better access to the Marshall Street Playground.

**Item #3** – Regarding the curb on the east side of Bonner Ave from 20 ft. north of Washington St to 10 ft. south of the fire hydrant near the driveway for 237 Washington St, request to convert 140 ft. of resident permit parking to meter parking.

#### **Item** #4 – Vitoria Meat Market Loading Zone Request

a) Regarding the curb on the north side of Somerville Ave, from 115 ft west to 150 ft west of Beech St and nearest 577 Somerville Ave, request to convert 35 ft of 2 hour parking except by permit to a loading zone from 8am to 8pm and resident permit parking at all other times.

## Item #5 – <u>La Petite Enfance Montessori School</u>, F45, and Kumon Loading Zone Request

- a) Regarding the curb on the east side of Greenville Street, from 70 ft south to 35 ft south of McGrath Highway and nearest 450 McGrath Highway, request to convert 35 ft of No Parking Any Time to a loading zone from 7am to 7pm and resident permit parking at all other times.
- b) Regarding the curb on the west side of Greenville Street, from 35 ft south to 70 ft south of McGrath Highway and nearest 252 Medford Street, request to convert 35 ft of resident permit parking to a loading zone from 7am to 7pm and resident permit parking at all other times.

### Item #6 – Shiso Kitchen and Sweet Laundry 2 Hour Parking Request

a) Regarding the curb on the south side of Washington Street, from 175 ft west to 60 ft west of Calvin Street and nearest 376 Washington Street, request to supersede item 2f of the July 2023 Traffic Commission Meeting and instead retain the existing 2 hour parking except by permit regulations for this 115 ft length of curb.

### **Item** #7 – Central Hill Curbside Management Pilot Extension Request

Request to extend the Central Hill curbside management pilot, originally approved at the November 18, 2021 Traffic Commission meeting, until June 30, 2025, consisting of the following:

- a) Approximately 15 parking spaces on the north side of Highland Ave, from opposite Putnam St to the City Hall driveway, regulated as City Hall or School Permit Parking Only from 7AM to 9AM Mon-Fri.
- b) Approximately 12 parking spaces on the north side of Highland Ave, between the entrance and exit to the Somerville High School Driveway, regulated as City Hall or School Permit Parking Only from 7AM to 9AM Mon-Fri.
- c) Approximately 7 parking spaces on the west side of Walnut St, between the Highland Ave and Medford St, regulated as City Hall or School Permit Parking Only from 7AM to 9AM Mon-Fri and otherwise as two hour parking except by permit.
- d) Approximately 9 parking spaces on the east side of Walnut St, between the Highland Ave and Medford St, regulated as City Hall or School Permit Parking Only from 7AM to 9AM Mon-Fri and otherwise as two hour parking except by permit.
- e) Approximately 9 parking spaces on the east side of School St, between Highland Ave and opposite Madison St, regulated as City Hall or School Permit Parking Only from 7AM to 9AM Mon-Fri and otherwise as two hour parking except by permit.
