Attorney Dash mentioned that the meeting was being recorded, stated the number of people in attendance, and went through the project details, property zoning designation, process going forward, and relief sought. Mr. Quinn went through the plans and explained the details of the proposal, being a façade refresh of the Twin City Plaza shopping center structure.

Public Comment was received both by written and oral means and can be summarized as follows:

- -all resident comments were favorable toward the proposed design and the updating of the Twin City Plaza façade.
- -a resident asked how the walkway lighting would be improved. Mr. Quinn stated that, while the lighting design is still in process, the plan is to have recessed lighting in the covered walkway.
- -a resident asked about whether the cornice lighting would be bright, and asked about the bird infestation. Mr. Quinn stated that the cornice lighting will be LED and will be downward facing to wash down the wall. Mr. Fitzpatrick stated that a bird specialist has been engaged and that wrapping the columns and adding wires on the top edge of the building should help with the bird issue.
- -a resident asked about construction impacts on access to the retail stores at the site, and whether changes will be made to the pedestrian and vehicular traffic at the site. Mr. Fitzpatrick stated that he does not anticipate the work limiting retail store access. Attorney Dash stated that the project does not involve any changes to the pedestrian or vehicular access or circulation at the site, as it is only a façade refresh of the existing building.
- -a resident asked whether there would be any green roof added to the structure. Attorney Dash said no, as the project is only a façade refresh of the existing building.
- -a resident asked about noise from construction and whether the building height would change. Attorney Dash stated that the building height will not change. Mr. Quinn stated that there should not be a lot of excessive construction noise due to the nature of the work.




PROPOSED FRONT ELEVATION
