Addendum No. 1 to IFB 25-38

Dear Bid holders,

This addendum (1) was issued to change the bid due time and provide answers to your questions.

Bid Due Time

The Bid Due Time is Now 2:30pm. The Bid Due Date remains Feb 3rd, 2025.

Questions and Answers

- 1. What company is the incumbent and what were the rates in the previous contract? The last vendor was W L French Excavating Corporation. For rates see attached price section for Re-bid IFB 20-65.
- 2. To which facility/landfill has the material been going for disposal over the past few years? Keystone Landfill, NH
- 3. In the background section of Section 2.0, there is a reference to the clean out activities of sewer and stormwater infrastructure. Is the grit to be disposed of from a combined sewer and stormwater system, or is it stormwater catch basin grit only? The grit material will be from catch basins not the sewer system. Catch basin can be connected to the sanitary sewer or dedicated drain system.
- 4. At the top of the second page of Section 2.0, the bid states that liners and covers shall be supplied by the contractor. The units of measurement are "per-sample" for the sampling, "per-hour" for the transportation, "per-month" for the rental, and "per-ton" for the disposal. Are liners actually required? If so, in which bid item should this cost be included? Liners are not required. Liners for the containers were not used previously. Covers references tarp or another device that will cover the container top completely.
- 5. The last sentence in the paragraph at the top of the same page states that "the lay down needs to be provided by the contractor". Does this mean the installation of a liner in each container? It looks like this was put in error. The City (Somerville) will provide lay down yard for the containers.
- 6. The second paragraph on the same page states that "containers shall be secured and covered at the end of each working day to minimize nuisance dust or odor conditions". Since the contractor isn't onsite at the City's staging yard on a daily basis, please confirm that this will be done by an employee of the City of Somerville and not by the contractor. City employees will be responsible for this duty.

- 7. The last sentence in the second paragraph on that same page states that "the contractor shall also secure the facility at the end of each working day". Since the contractor isn't onsite at the City's staging yard on a daily basis, please confirm that this means that the contractor shall secure the facility only on days when it is delivering an empty container and/or picking up a full container. City employees will be responsible for this duty except for days of picking up and delivery of containers.
- 8. This does not appear to be a service we would provide. We offer our own containers to leave onsite for you to load but it doesn't look like this would be. We would not load the 30yd or 20yd containers we would leave onsite. The vendor is supposed to supply the cans and we fill them not the vendor. They just haul it away.
- 9 Do you know if there is Sewage in the material? Some catch basins are connected to the combined system, but unless the was a severe issue with the sewer system I would say there is no sewage in the material.
- 10. Are vendors bidding allowed to grab samples before entering a Bid? I'm not sure where you would take samples from as we have over four thousand catch basins throughout the city. We would not be opposed to samples being taken.
- 11. Does Somerville have analytical on the material that we are bidding on? No.
- 12. Is a bid bond required to be submitted with this RFP? Are payment and/or performance bonds required if awarded? No. bid, payment and performance bonds are not required for Goods and Services Contracts.

- Subpart 1C / 2C: the unit price per month for roll-off container rentals to store and manage material prior to reuse/disposal.
- Subpart 1D / 2D: the unit price per ton of grit to be handled, managed, and reused/disposed of at an appropriate facility.

The contract unit price shall constitute full compensation for furnishing all labor, materials, tools and equipment for completion of the Scope of Work outlined herein.
