Questions and Answers

Below are the answers to questions that came in after the latest proposal extension.

Question 1: Can the EEA Planning Assistance application and scope of work be shared to help develop more precise cost estimators.

Question 2: What is the expected level of public engagement? Will the selected vendor need to attend public meetings, if so, how many?

Answer: The vendor will facilitate and attend up to 10 focus groups with relevant stakeholder groups (approximately 10 people per focus group) that are sufficient to answer questions and captures the requisite diversity of voices in the community (see Task 2 in RFP).

It is not expected that the vendor will attend general public hearings or any other meetings that are open to the public.

Question 3: It is the expectation that the vendor will provide actual zoning code to be adopted, or general policy language?

The City expects the vendor to provide general policy language.

Question 4: Architectural Elements: are you expecting diagrams and drawings, or more data visualization and analytics?

Answer: The City expects data visualization and analytics primarily, with architectural diagrams and drawings as needed.
