### Legal Questions

#### Conflict of Interest Law

- Applies to All Municipal Employees: As a municipal employee, both you and members of the board or committee above, even if unpaid and serving solely in an advisory capacity, are considered amunicipal employee and are covered by the conflict of interest law, G.L. c. 268A.

#### **Open Meeting Law**

- A meeting is "a deliberation by a public body with respect to any matter within the body's jurisdiction."
- **Deliberation** is "an oral or written communication through any medium, including electronic mail, between or among a quorum of a public body on any public business within its jurisdiction."
- Distribution of a meeting agenda, scheduling or procedural information, or reports or documents that may be discussed at a meeting to board or committee members will generally not

- **constitute deliberation**, provided that no member expresses an opinion.
- E-mail exchanges between or among a quorum of the members of a public body discussing matters within that body's jurisdiction may constitute deliberation.
- A quorum is usually a simple majority of the members of a public body.
- Minutes: Public bodies are required to create and maintain accurate minutes of all meetings, including executive sessions. Minutes must state: the date, time and place of the meeting, a list of the members present or absent, a summary of discussion of each topic, and the decisions made and actions taken including a record of all votes. Minutes must be created and approved in a timely manner.

#### **FAQs**

#### What is quorum for SBAC?

• The current quorum is 9. There are 16 active members on SBAC, including ex-officio members. A public SBAC meeting cannot be held without quorum.

#### Who can participate in sub-committee meetings?

Only SBAC members can participate in sub-committee meetings. Sub-committee
meetings must have fewer members than quorum in attendance (fewer than 9
currently), otherwise they must be public meetings and posted according to City
policies.

#### When should I use Bcc on an email?

Use Bcc if the number of members on the email is equal to quorum or greater.
 Emails of this size should be sent only for sharing information and not for discussion.

#### How do I request an item for a meeting agenda?

Send agenda item requests to the SBAC officers and staff liaisons.



Somerville's annual bike count program continued in 2024; average counts were lower than 2023 but higher than 2022




Public bikeshare continued to set records in 2024; our Bluebikes system reported more than 4.5 million trips

#### Public bikeshare continued to set records in 2024; more than 250,000 Bluebikes trips began in Somerville



# 2024 KPI – Travel Patterns - Bicycling


#### Public bikeshare is well-used all year round; Somerville set new records for each month of the year








# 2024 KPI – Safety Trends - Crashes


Reported crashes in Somerville continued to decrease in 2024; with 623 total crashes reported for the year

In 2024 Somerville experienced 11 severe injury crashes, but had no fatal crashes for the second year in a row



# Bicycle crashes reported in Somerville decreased in 2024, and our overall trend is downward



#### 2024 KPI – Strategies – Streets and Sidewalks

In 2024 we expanded our pavement markings program;

#### we prioritized crosswalks, clear corners, and bike lanes

#### Crosswalks

- Refreshed 254 faded crosswalks
- Added <u>46</u> new crosswalks, 7 of which were raised

#### Clear Corners


- Refreshed faded markings at <u>27</u> intersections along Broadway
- Added new markings or otherwise improved visibility at <u>70</u> intersections
- "SCHOOL" markings
  - Refreshed <u>11</u> faded markings
  - Added <u>17</u> new markings

#### Bike Lanes

- Refreshed 2.5 miles of faded bike lane markings on 8 different streets
- Added green paint to <u>1600 feet</u> of existing bike lanes on Park St, Medford St, and Cutter Ave



# Somerville continues to grow our bicycle network, we installed 2.2 miles of protected bike lanes in 2024



Somerville continues to grow our bicycle network, in 2024 we completed a major project on Washington Street



#### **Complete Streets Projects**

- West Broadway Design
  - Final plans expected early 2025
- Tufts St Bidding
  - Currently out to BID (seeking contractor)
- Western Pearl Design
  - 25% Design in progress

#### **Quick-Build Projects**

- Elm/Beacon Design
  - Public meeting anticipated in late winter/early spring to introduce concept design
