SO WE VOTED IN JANUARY AND IT WAS A CONTINGENT VOTE THAT WE WERE TO RECEIVE THE INVOICE AND THE INFORMATION ABOUT WHAT SWINGS IS BEING RECOMMENDED AS WELL AS THE INVOICE TO UNDERSTAND THE COST INVOLVED.

ALSO, TO BE ABLE TO HAVE A DISCUSSION WITH THE TEAM.

WE WERE TOLD THAT WOULD TAKE ONE OR TWO DAYS, AND IT'S A LITTLE BIT LONGER.

WHEN WE GOT IT, IT WASN'T -- IT WAS AN UPDATE AND A DECISION.

I PUSHED BACK AS THE CHAIR BECAUSE IT ALSO TALKS ABOUT THE PURCHASE ORDER READY TO GO AND OUR MONEY IS NOT BEING GIVEN WITHOUT OUR SIGNATURE.

ALSO, THE VOTE WAS TAKEN WITH CONDITIONS.

AND THEN ALSO, THE US SAFETY CONSUMER STANDARD CONSUMER SAFETY AFT -- BEAR WITH ME ONE MOMENT PLEASE.

>> AND SO WE WERE ASKED SHEILA AND I WERE AND TO GO BACK AND DISCUSS WITH THE GROUP CAN WHAT WELL LIKE IN THE SWINGS AND WE HAVE SHARED THAT, WE FELT THERE SHOULD BE BETTER DOCUMENTATION, THERE SHOULD BE TWO DIFFERENT TYPES OF SWINGS.

ONE THAT HAS MORE SUPPORT, AND MORE CONSTRUCTION AND A SWING BACK WITH A LOCKING MECHANISM.

YOU DON'T WANT THEM TO JUMP OFF IN THE MIDDLE OF THE SWING.

THAT'S MORE OF THE DESIGN OF THAT SWING.

SO, WE ASKED TO MULL THAT OVER AND GET BACK WITH THE COMMISSION.

I DID SOME RESEARCH AND I FOUND OUT THAT THERE IS -- THAT THE JEN SWING IS, IT HAS TO BE AND IT'S ALSO THE SWINGS THAT FITS IN THE PARK OVER BY --

AND THEY'RE IN OTHER PLACES AS WELL.

I WANTED US TO HAVE A CONVERSATION SO THAT WE COULD GIVE PARKS SOME FEEDBACK.

SO I'M GOING TO OPEN IT UP FOR DISCUSSION.
ANYONE WOULD LIKE TO START WITH THEIR THOUGHTS ARE,
AND I'M GOING TO ALSO, THE TIME ON THIS. I REALIZE
WE'VE LOST SOME TIME ALREADY.

OKAY.

SHE CAN DIAL IN BY PHONE.

>> SO IT IS 7:48, I'M GOING TO STOP THE CONVERSATION AT 7:58.

SO, IF ANY OF THE MEMBERS WANT TO ASK ANY QUESTIONS OR FEEDBACK ABOUT THE SWINGS I THINK, WE'VE HAD ISSUES WITH THE MINUTES NOT HAVING EVERYTHING IN THEM AND, THE MINUTES DID NOT REFLECT THAT IT WAS A VOTE, BUT IT WAS ON THE VIDEO AND THE TRANSCRIPT.

AND SO I'M OPENING UP THE FLOOR IF ANYONE WOULD LIKE TO ASK ANY QUESTIONS OR HAVE ANY THOUGHTS ABOUT THE DIFFERENT SWINGS.

- >>> SO, THE BIG SEAT AND THE DUAL SWINGS.
- >> THERE WAS A SURVEY SENT OUT, WE WOULD HAVE TWO SWINGS IN IT, AND RED AND LONGER SWING WITH THE STRAPS. THAT HOLD YOU IN TIGHT.
  - >> WHEN YOU SAID.

>> THERE'S ABOUT FOUR AND THERE IS ONE THAT IS A SWING THAT IS MADE IN THE US.

AND THEN THERE IS A SWING THAT WAS THE ONE THAT PARKS HAD DECIDED WAS A SAFETY ONE AND THAT EVERYBODY IS BECAUSE THEY DIDN'T KNOW THAT THAT SWING IS NOT IN OTHER PARKS.

IT TOOK ME A WHILE TO FIND IT.

HOW CAN IT BE IN ANY OTHER PARK IF IT IS NOT SAFE?

>>> THE INTERESTING PART IS, IF YOU READ THE NATIONAL SAFETY STANDARDS, ANY SWING THAT YOU ADD THE NETTING TO IT, BECOMES A CHOKING HAZARD.

IF ANYONE IS UNSUPERVISED.

BUT, THE SWING THAT IS, THAT HAS THE SEAT, THAT SWING ALSO COMES WITH THE NETTING AND WOULD ALSO POSE THE SAME CHOKING HAZARD.

SO IT IS VERY, IT'S DIFFICULT TO UNDERSTAND WHY THEY HAVE THEM, SO THAT THEY CAN BE SAFE, FOR PEOPLE WHO DON'T HAVE A LOT OF CONTROL.

BUT, THEY CAN CREATE IT.

IF SOME CHILD WAS ON -- WAS NOT BEING WATCHED AND DECIDED TO HANG THEMSELVES FROM THE STRAPS IN THE PARK.

WHICH NONE OF US WOULD EVER WANT THAT TO BE. [INAUDIBLE]

- >> I ALREADY SENT THE LINK.
- >> DOES ANYONE ELSE HAVE ANY QUESTIONS OR COMMENTS ABOUT THE SWINGS?

I KNOW WE WOULD ALL LIKE TO HAVE SWINGS DONE AND KIDS PLAYING.

NO.

ALL RIGHT.

>> SO, THE QUESTION IS, HOW DO YOU WANT TO PROCEED, WITHONE PARTICULAR STYLE OR DIFFERENT STYLE SWINGS?

I COULDN'T HEAR YOU.

>> IASKED IF WHAT WE ARE VOTING FOR, OR TALKING ABOUT, IS THAT WHETHER ONE SPECIFIC CHAIR WE PREFER, OR WHETHER WE WANT TWO DIFFERENT STYLES WHICH I THINK YOU KNOW, I DON'T THINK THERE ARE MANY SPECIFIC CHILDREN, AND THERE ARE SOME CHILDREN THAT WOULD DO BETTER IN ONE STYLE THAN THE OTHER AND I THINK IF WE WERE ABLE TO PROVIDE BOTH, FAMILIES COULD HAVE THEIR CHILDREN GO TO THE ONE THAT SERVES THEM THE BEST.

>> NICOLE HAS HER HAND UP.

>> NICOLE.

YOU'RE MUTED.

SO SORRY.

HI EVERYONE, YEA, JUST A QUICK COUPLE OF COMMENTS.

FIRST IS, I JUST WANT TO THANK THE MEMBERS ON THE COMMISSION FOR JUST STICKING WITH THIS SO IT HAS BEEN LIKE A MARATHON AND I WANT TO THANK EVERYONE FOR ADVOCATING FOR THIS.

ITHINK, IT'S IMPORTANT RIGHT FOR KIDS THAT DON'T HAVE ANYTHING TO DO ON OUR CITY PLAYGROUNDS.

I THINK IT -- I THINK IT MAKES SENSE TO, SINCE THERE WERE THE TWO DIFFERENT SWINGS INCLUDED IN THE SURVEY TO HAVE THAT REPRESENTED.

SO MAYBE TO DO 50/50.

THERE MIGHT BE OTHER OPINIONS ON THIS. I THINK

WHERE THE DECISION WAS PUT THAT BOTH SHOULD BE CONSIDERED.

- >> OKAY.
- >> I'M JUST GOING TO SHARE IT NOW ALTHOUGH IT WOULD HAVE BEEN PART OF THE REPORT ON LEGISLATIVE MATTER.

BUT THERE WAS A COMMITTEE MEETING, ON PUBLIC SAFETY, AND THERE WAS A LETTER THAT LOUISA HAD WROTE, IN RESPONSE TO ASKING FOR AN UPDATE ON THE SWINGS AS WELL AS THE UNIVERSAL PLAN FOR THE PART OF THE KENNEDY SCHOOL AND SEVERAL TESTIFIED AND I WOULD JUST LIKE TO REITERATE THAT I THOUGHT THAT WHOLE LETTER THAT LOUISA WROTE WAS WONDERFUL IN SO MANY WAYS, BECAUSE WHAT SHE TALKED ABOUT IS THAT ADA IS NOT ENOUGH.

JUST HAVING A PARK THAT'S ADA COMPLIANT DOESN'T GIVE KIDS ENOUGH TIME TO PLAY ON EVERYTHING.

IT DOESN'T FORCE EVERYTHING TO BE.

HAVING A ROOF TO A SWING IS NOT ENOUGH.

THAT'S A SWING TO RIDE ON.

AND SHE ALSO TALKED ABOUT HOW THEY DESIGN IN THE CITY, ACCESSIBLE PARKS.

BUT OVER TIME THINGS CAN CHANGE, I CLAIMED IN MY TESTIMONY, THAT WHAT HAPPENS IS NOT THE FAULT OF THE PARKS DEPARTMENT, THE DESIGNERS, OR ANY PEOPLE WITHIN THE CITY, IT IS A LACK OF MAINTENANCE.

IF THEY ARE NOT FIXING IT AND MAINTAINING THE EQUIPMENT THEN THEY BECOME INACCESSIBLE.

WHICH IS WHAT A LOT OF PARKS HAVE BECOME AND WHAT I ASKED INDEED SUPPORT OF MAKING SURE THAT WHATEVER IS BUILT AT THE KENNEDY AND ALL OF OUR PARKS THAT A CITY COUNSELORS PUT THROUGH TO INCLUDE SPECIFIC AMOUNTS FOR PARKS TO BE MAINTAINED.

BECAUSE IT WOULD BE A VERY BIG WASTE TO SPEND MILLIONS OF DOLLARS ON A PLAYGROUND, THAT WILL BE FULLY ACCESSIBLE AND NOT MAINTAINED.

I THINK THAT WE OWE THAT TO PEOPLE IN THE CITY THAT WORK REALLY HARD TO PLAN THESE PARKS.

TO MAINTAIN THESE PARKS.

IF THEY HAVE ENOUGH STAFF AND MATERIAL THAT THEY NEED.

BECAUSE IT IS NOT FAIR FOR LOUISA AND ALL THE PEOPLE IN THE CITY WHO DO ALL OF THIS WORK, WE'RE TOLD THIS IS INACCESSIBLE THROUGH MAINTENANCE.

I REALLY APPRECIATED WHAT SHE SAID BETWEEN THE

LINES ABOUT CALLING OUT THE ISSUE.

BUT I FEEL THE ISSUE IS MAINTENANCE AND SO AS A CITY WE NEED TO RESPOND TO THAT.

I DID ALSO SAY THAT THE SWINGS WERE IN THE COURT OF THE COMMISSION.

THIS WAS NOT ON THE PART OF THEM.

I THINK THERE ARE ALREADY SEVERAL OF THE SWINGS OF THESE SWINGS IN THE DIFFERENT PARKS AND WE CAN JUST BALANCE IT OUT.

>> I WAS SAYING THEY HAVE IN THEIR RESEARCH DID NOT FIND THAT THAT JEN SWINGS, AND IT IS COMPLIANCE WITH THOSE TWO.

THAT'S BECAUSE WHEN YOU LOOK FOR WHERE IT IS MADE, IT IS NOT IN THE PARK.

IF HER TEAM WOULD RECONSIDER HAVING TWO DIFFERENT TYPES OF SWINGS.

BUT THEN, THERE WERE SEVERAL OTHER PEOPLE WHO SPOKE AT THAT EVENT.

SO, WE'RE GOING TO MOVE ONTO OUR NEXT ITEM WHICH IS RSJ COLLABORATION.

WE WERE ASKED ABOUT WHEN THIS MIGHT, SHEILA AND HARRIOTTE, TO TALK ABOUT SWINGS AND AMANDA AND IT WAS DIRECTOR OF RSJ, IT WAS LISA, AND ADRIENNE AND IT WAS TO TALK ABOUT AN UPDATE.

WE GO AND SPEAK AT CITY COUNCIL.

SOMETIMES, THE LEADERSHIP TEAM ALSO DIRECTLY WORKS ON THINGS LIKE BEHIND THE SCENES.

THE MAJORITY OF PEOPLE DON'T KNOW HAPPENED, AND THAT PART OF THE ROLE THAT WE HAVE.

BUT THIS WAS A VERY UNCOMFORTABLE CONVERSATION. BECAUSE MEMBERS OF MY TEAM WERE REALLY

UNCOMFORTABLE WITH IT, IT FELT IT WAS IMPORTANT THAT IT WAS DISCUSSED OR IT WAS SHARED.

BECAUSE WHAT WAS, WHAT WE WERE TOLD WAS THAT WE'RE NOT HONEST.

THAT WE DON'T SHARE ALL OF THE INFORMATION BACK WITH THE MEMBERS.

AND THAT THAT FELT VERY UNCOMFORTABLE.

IT ALSO TALKS ABOUT THAT OUR MEMBERS WERE VERY INAPPROPRIATE WHEN MEG AND DAWN PRESENTED TO THE MEETING.

WHAT REALLY UPSET ME WAS THAT SOME OF US GOT UPSET FROM OCTOBER, WHY WOULD YOU WAIT UNTIL THE FIRST -- FEBRUARY TO TELL US.

BECAUSE I WOULD NEVER WANT ANYONE TO COME TO OUR MEETINGS AND BE UPSET AND I APOLOGIZED FOR THAT AND I AGAIN EXPRESSED THE SAME THING I SAID THEN, I HAVE NEVER BEEN ALLOWED TO TALK TO THAT PERSON AND I WENT BACK AND I'M SURE OTHERS DID AS WELL FROM THE GROUP AND LOOKED AT THE RECORDINGS AND, LISTENED TO WHAT WAS SAID.

THERE WAS A FEW COMMENTS THAT WERE TAKEN FROM THE PUBLIC THAT MAYBE THOUGHT THEY WERE SAYING SOMETHING THAT WASN'T VERY KIND.

THERE WAS A LOT OF THINGS THAT WENT ON AT THAT MEETING.

WE HAD A LOT OF ITEMS, I DON'T THINK IT WAS SET UP PROPERLY.

WHEN ANYONE COMES TO TALK TO OUR MEETINGS I GO OVER WITH THEM WHAT THE PRESENTATIONS ARE.

I GO OVER WITH THEM WHAT THE MOOD OF THE GROUP IS GOING TO BE, DEPENDING ON WHAT THEY'RE TRYING TO PRESENT.

WHAT THEY NEED TO GET OUT AND KEY THINGS ARE ALWAYS, WE ALREADY UNDERSTAND THIS PIECE BUT WE DON'T UNDERSTAND THAT PIECE.

ALSO DON'T HAVE A LOT OF VISUALS UNLESS PEOPLE CAN TALK AND THIS IS THE TIME-FRAME IN WHICH YOU WANT TO STAY WITHIN.

THAT PERSON I WAS NOT ALLOWED TO HAVE THAT CONVERSATION.

IT WAS NOT ANYONE'S FAULT WHO PRESENTED, IT IS NOT ANYONE'S STAFF OR EMPLOYEE THAT WANTED THIS TO HAPPEN.

I REALLY DON'T, I FEEL HORRIBLE TO SAY WE'RE UPSET BUT I'M MORE UPSET THAT WE WERE TOLD THAT WE WERE NOT HONEST AND WE DO NOT SHARE EVERYTHING WITH THE COMMISSION.

FOR THAT REASON, MEMBERS OF RSJ ARE COMMUNICATING WITH ALL OF US.

I'M GOING TO AGAIN SAY ALL COMMUNICATIONS TO THE MEMBERS GO THROUGH THE CHAIR AND THERE'S NOT TO BE CONVERSATIONS OUTSIDE OF MEETINGS, WITHOUT GOING THROUGH CHAIR.

I PRINTED OFF MESSAGES, IN THE LAST FEW HOURS OF ALL OF THE THINGS TO SEE THAT I HAVEN'T SHARED BECAUSE THERE WERE THINGS LIKE ARGUING ABOUT WHO CAN MAKE A PHONECALL ABOUT A FOOD MEAL OR WHAT NAME SHOULD BE ON AN INVOICE OR THAT NO ONE ON A COMMISSION IS ALLOWED TO SPEAK TO ANYONE WITHIN THE CITY?

EVEN AS A RESIDENT.

>> ITHINKIT'S VERY IMPORTANT THAT COMMISSION BE WELL-KNOWN OF ALL THE THINGS THAT ARE HAPPENING THAT ARE NOT COACHED.

AGENDAS ARE MADE BY THE CHAIR, THEY ARE SET BY THE CHAIR.

EVERYONE IN THIS ROOM HAS A VOICE.

I VALUE ALL OF IT.

EVERYONE SHOULD KNOW IF YOU DON'T KNOW, IF YOU SEE SOMETHING, OR YOU HAVE AN IDEA OR YOU HAVE A QUESTION, YOU BRING IT TO ME, YOU WILL PUT IT ON THE AGENDA AND WE WILL TALK ABOUT IT. ALL INPUTS ARE WELCOME.

WE WORK ON SO MANY PROJECTS.

WE SCRAMBLE TO GET FLAG RAISED AND WE SCRAMBLED TO GET TENTS RAISED AT ART SHOWS, WE LINE UP FOLKS AT THE LIBRARY.

WE SPEND OUR OWN TIME, HOURS AND HOURS, TRYING TO ADVANCE THE NEEDS AND RECOGNIZE AND CELEBRATE PEOPLE WITH DISABILITIES IN THE CITY.

WE ARE NOT BAD PEOPLE.

BUT WHOEVER IS SAYING THINGS ABOUT OUR CHARACTER, NOT IN FRONT OF, NEEDS TO STOP.

BECAUSE I WILL NOT ALLOW SOMEONE TO SAY WE HAVE

DONE SOMETHING WRONG IF WE HAVEN'T.

IF WE HAVE AND I'M NOT AWARE OF, IF I HAVE, I WILL OWN IT AND I WILL APOLOGIZE, BUT I WILL NOT BE BULLIED.

WOULD YOU LIKE TO ADD ANYTHING?

- BECAUSE DIRECTOR WILLIAMS TOLD YOU SO, IN THE FALL.
  - AND YOU HAVE DEFIED THAT ALMOST TWICE NOW.
  - >> THAT'S BECAUSE IT IS A MEETING.
  - >> AND THE ADA COORDINATOR HAS A REPORT.
  - DO NOT SHAKE YOUR HEAD SHEILA.
  - >> NO, THIS MEETING IS OVER.
- >> SORRY EVERYONE, THIS IS NOT HOW IT IS SUPPOSED TO GO AND I AM ENDING IT AND WE CAN ALL GO HOME.
