Attorney Dash went through the project details for a Tropical Smoothie Café at Twin City Plaza, the property details, the process going forward, and the relief sought. He went through the site and floor plans, and the exterior photograph.

Councilor Scott then explained how the public could either speak or type questions or comments using the chat function.

Public Comment can be summarized as follows:

A resident asked about the proposed hours of operation. Hardik Patel said they are proposed to be 7:00 am until 9:00 pm.

A Cambridge neighbor thanked Applicant for the presentation and said that the proposal looked good.

Councilor Scott said that he had no questions or comments, and that this would just be the replacement of one formula business with another at Twin City Plaza.

Seeing no further comments or questions, Councilor Ewen-Campen thanked everyone for attending and closed the meeting.

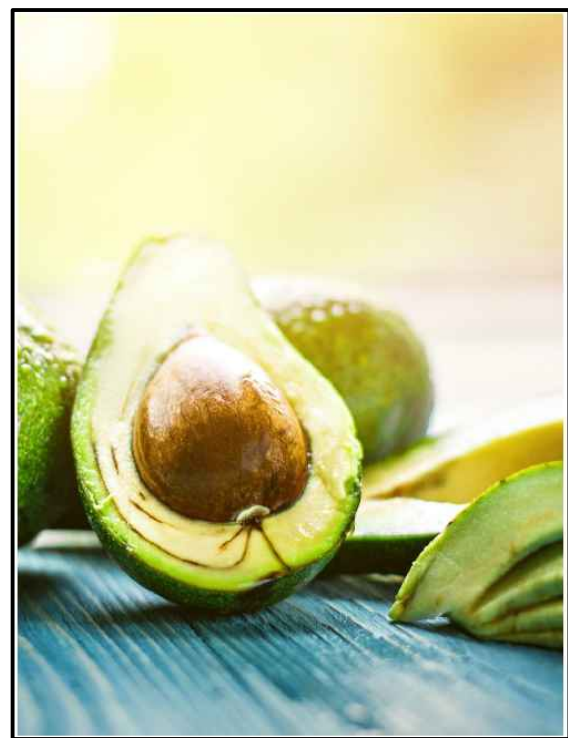

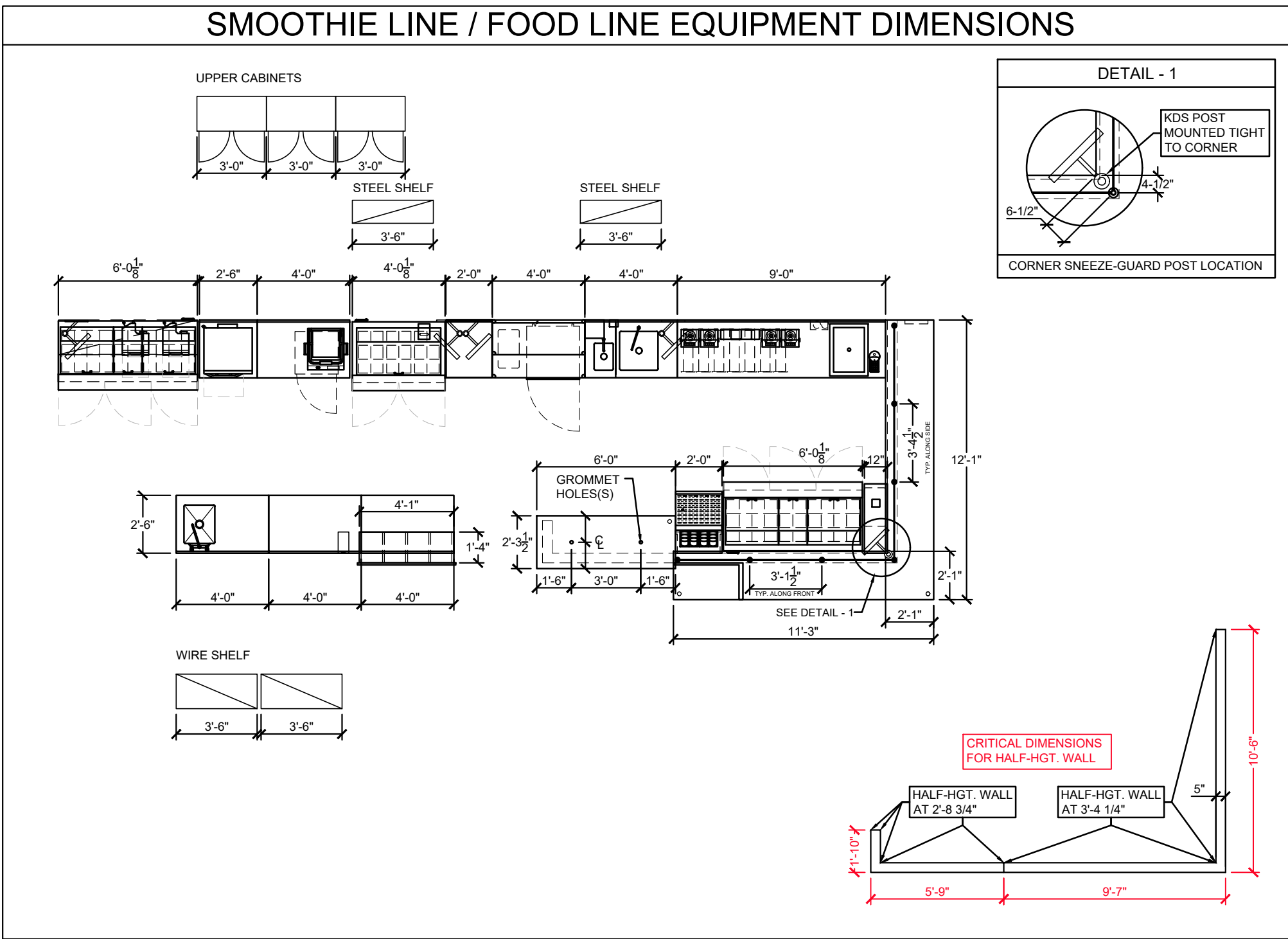

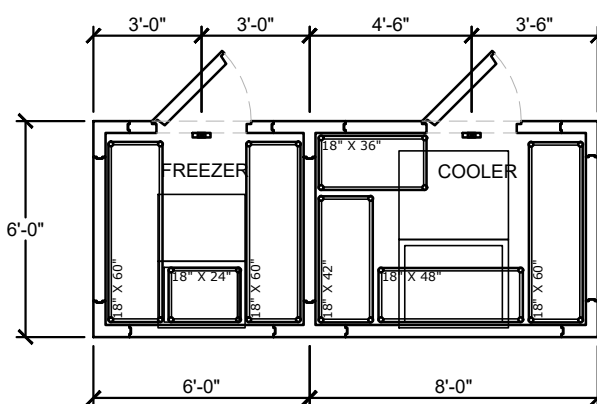
