1.	What is the estimated project cost?	\$22,000.00	
2.	When were the courts last resurfaced?	3-4 years ago, when the athletic field at Conway Park was built.	
3.	Will the pickleball courts be centered on the halves of the basketball court?	Yes, with not shared lines between the basketball and pickleball court lines.	
4.	Is the basketball court key to remain gray?	Yes. The colors will be kept the same as the existing paint job.	
5.	What size will the pickleball courts be? The existing pickleball courts are not regulation size.	The new pickleball courts will be regulation size, 20 ft. × 44 ft. The 20 ft. length will be centered between the half court line and foul line of the basketball court. The 44 ft. length will be centered on the short dimension of the basketball court.	
6.	Does the scope of work include power washing?	Yes. The scope of work includes all proper prep work, repainting and relining.	
7.	Where can we park our trailers/equipment?	DPW will arrange for sufficient parking in the lot next to the basketball courts.	
8.	Who will be responsible for keeping the courts clear and blocked off during the curing process?	The Contractor will be responsible for all fencing or other materials required to prevent public access to the court while the new paint cures. DPW will lock the two gates from the skating rinks.
