Changes to the Scope of Work:

Due to the visibly poor external and unknown internal conditions of the masonry chimney, the chimney flue lining installation section of the Scope of Work (Bullet Point 5.n.) will be replaced with the following:

Extend boiler flue horizontally through the existing window opening in the south-facing exterior wall of the boiler room. On the exterior of the building, transition the flue to vertical and extend to a code compliant height above the roof line. Provide crane service, staging, etc., as needed for external flue installation.

In light of the change in scope above, the answers to the boiler flue and chimney questions that were released in Addendum 2 have been updated as follows:
