Councilors Clingan and Ewen-Campen welcomed everyone and introduced themselves before handing the floor over to Attorney Dash. Attorney Dash said that the meeting was being recorded, and stated the purpose of the meeting.

Attorney Dash went through the project details for a Brazilian-style bakery, café and coffee shop, which requires a use special permit, at the property. He explained the project details, the process going forward, and the relief sought. He went through the floor plans and exterior photographs.

Attorney Dash then explained how the public could either speak or type questions or comments using the Q&A function.

Public Comment can be summarized as follows:

The residents were all positive, supportive and excited about the proposal, including representatives of the Gilman Square Neighborhood Council, as well as very close abutters.

A resident asked about the proposed hours of operation. Attorney Dash and Ms. Antunes said they are not yet known.

A resident said they were supportive of the use, but had concerns about parking. Attorney Dash said that there would be more activity than the current vacant storefront, but that there are a lot of people who pass by the site during the day, and that the site is close to the Gilman Square T station, such that the proposed use would not likely create additional traffic and parking issues.

Some local business workers expressed their support and said they would frequent the new business.

Seeing no further comments or questions, Councilor Clingan thanked everyone for attending and closed the meeting.

The meeting was adjourned at 6:50 pm.


