Attorney Anne Vigorito appeared on behalf of the applicants, Benjamin Argueta and Tony Figueroa, who were also present, and stated that this application reflects a sale of the business where no changes will be made whatsoever, including to: hours, menu, seating, and alcohol service. Attorney Vigorito continued that the new owners are previous employees of the business and know it well, and that the proposed manager has been working there for 20 years. Attorney Vigorito stated that all staff are TIPS certified, and that the business has no recorded violations.

Commissioner Allen asked about the policy regarding 2:00 a.m. alcohol service, and Chair Lynch stated that granting that license is discretionary, but that in this case the applicant's business has already been operating with a 2:00 a.m. license with no violations, and that he would not object to allowing that to continue.

Director Postlewaite stated that the applicant's outdoor seating layout is unchanged, and that it is recommended for approval.

Chair Lynch opened the public hearing. No members of the public offered comments on this Item. Chair Lynch closed the public hearing.



Dear Somerville Licensing Commission and Inspectional Services Division,

I am writing to formally submit a complaint regarding ongoing disturbances and possible licensing violations at **Gauchao Brazilian Cuisine**, located at **102 Broadway, Somerville, MA**, which have significantly impacted the quality of life on our street.

Since a change in ownership earlier this year, the restaurant seems to have started running a nightclub on weekend nights. On **Friday through Sunday nights**, they host loud latenight events with loud **music and excessive bass** continuing until **1:30 AM**. The bass is set so loud that it can be heard and **felt inside our home** on Cutter Street. It can also be felt by the residential homes on Broadway, and across the street on Michigan/Illinois Ave.

We have called the **non-emergency police line** on multiple occasions, and while officers have responded and asked them to lower the music, the volume picks up again shortly after the officers leave. This has happened every weekend for the last few months, with no long-term resolution or end in sight. <u>The restaurant's Instagram page</u> is actively promoting these nightclub events.

Aside from the extreme noise, we are increasingly concerned about the public safety.

There recently were shots fired (incident report linked) outside of the restaurant with a crowd of over 100 people. Thankfully no one was injured, but we are concerned should this type of escalated behavior happen again.

We are also concerned with the idea of 100s of intoxicated patrons leaving the venue at 1:30AM and loitering on our residential street or potentially walking into our ungated driveway and yard.

We would like to request:

- **1 A review of Gauchao's entertainment and alcohol licenses**, including whether they are permitted to host nightclub-style events or use amplified sound past 11:00 PM.
- 2 Enforcement of noise ordinances and zoning rules for mixed-use areas.
- **3 Monitoring or inspection of noise levels**, particularly the low-frequency bass disturbances that can be felt inside nearby homes.
- 4 A response outlining what steps will be taken to investigate and address these concerns.

We value our neighborhood and understand that Somerville is a vibrant community and living off of Broadway comes with noise and crowds — but the ongoing disturbances and safety risks are disruptive, stress-inducing, and beyond the norm for the area. Thank you for your time and attention to this matter.



On Saturday, May 24, 2024, while working my assigned shift in marked unit East-1, I placed myself on a directed patrol in front of 102 Broadway (Gauchao Brazilian Cuisine) due to recent incidents involving disputes and fights at the location. I'd like to note that over the past few weeks, there have been multiple incidents that began to escalate, but I was able to step in before anything became physical.

At around 0130 hours, while parked across the street directly in front of the restaurant, I saw a group of males leaving the bar. One of them who will be referred to as Male 1 seemed visibly upset and was heard yelling in Portuguese, saying things like, "He has no respect. Tell him to come outside," and "Hes a faggot." Security appeared to be stepping in and seemed to have things under control, walking Male 1 away from the

entrance.

As more people started coming out of the restaurant, I saw Male 1 lunge forward and appear to push another male, who will be referred to as Male 2. At that point, I was already on foot and stepped in along with security to separate both individuals. I requested additional units, and marked units East-4 (Officer Kartso) and East-3 (Officer Martins) responded to assist.

Both parties were clearly intoxicated, slurring their words to the point where it was difficult to get much information from either of them. After speaking with witnesses, it appeared that Male 1 had been pushed by Male 2 inside the bar, which sparked a verbal argument and led to Male 1 being removed by security. That removal seemed to further upset Male 1, leading to the events I witnessed outside.

After speaking with Male 1, he eventually calmed down. He told me he didn't want anything done and that his Uber was arriving shortly and he just wanted to go home. Both parties were advised and left without further incident.

I'd also like to note that multiple incidents involving disputes at this location have occurred around 0200 hours, and Gauchao appears to be operating well past their listed closing time. According to their website, they are supposed to close at either 0030 or 0100 hours.



On 4/27/25 I was working Patrol in E1 on a LH shift. At around 0027, Somerville E911 received multiple 911 calls regarding a shooting at or in the area of Broadway/Cutter. I was dispatched along with multiple other units including OFC D Prophete (E2), OFC D Ruf (E3) and OFC R Sullivan (E4). SGT S Scrugli (S8) also responded. While enroute, SPD Eq11 received more calls regarding a "fight" at the same location.

I arrived and noted heavy vehicle traffic in front of 102/104 Broadway, "Gauchao Brazilian Cuisine" (BHC.) This property abuts Broadway/Cutter. I observed about 10+ pedestrians on foot in the immediate area. Nobody was approaching me to tell me anything of value. I spoke to Mr. M Hairera, a staff member at BHC. He told me that someone fired a gun into the air. However, he did not see it occur. I was unable to obtain any of his bio info

other then a phone number. He told me that nobody in BHC saw anything of value. E4 would later view CCTV from GHC. This video does not show the crime but does show people fleeing west on Broadway in front of GBC during the incident. Units checked the area for ballistics. I found one spent shell in front of 96 Broadway. CID was notified and Detectives A Monaco and C Collette responded. See their reports. There was no shot spotter activation.

spoke to Officers. He was across the street and heard one to two sounds that sounded like gunfire. He did not report seeing anything. He refused to give us any of his bio info other then a phone number.

Earlier in the evening I responded to a 911 hang up call that hit within "86 meters" from the area of "105 Broadway" at around 2358 (25022976.) E911 called back and left a voicemail. The number involved was 339-242-3704. I arrived and checked the area. I witnessed at least 100 people in front of GHB and seemed to be in a line waiting to get in. Nobody was flagging me down and nobody appeared to be in distress. I drove into the back parking lot behind the old East End Grill (118 Broadway.) I noted several people but no one flagged me down and no one appeared to be in distress. I also drove down Broadway to about Broadway and MT Vernon and I drove down Glen ST to Pearl ST. Likewise, nobody was flagging me down and nobody appeared to be in distress.



Hi Joe,

I've been trying to connect with you for a while but have been overwhelmed with other business. My name is Diogo DeOliveira, I am the newly appointed Lieutenant for the Criminal Investigations Division, replacing Captain Sheehan. I've also been asked to handle some of the duties related to liquor laws violations until a replacement for Lieutenant Mitsakis has been named, to alleviate the Captain's workload as he is in now charge of the entire patrol division and more. I'd love to connect in person at some point if you have the time, my work number is anytime.

I got involved with Gauchao Brazilian Cuisine right at the time of the shooting that happened there on 4/27. While the shooting was not recorded at their address, it was called in at the corner of Broadway and Cutter, we discovered through witnesses that it did involved people that were there and had exited the establishment, and were loitering outside (which is part of the problem which I'll get to it). The shooting happened on 4/27 and I met with Michael Herrera, who is the son's owner and manager, on 5/1. We spoke for a few minutes, at the time I felt like Mike had done what he's supposed to do: hired private security, checking people at the door, security inside, and he even closed early because he noticed that it was getting a little wild. The clientele Gauchao is attracting is a younger clientele, different then they were used to, and it is a clientele that likes to get "wild". I advised Mike to stay on top of it because recurring events could jeopardize his ability to operate. Since I met with him there were multiple additional complaints for noise, disputes, disorderly persons, even a fight. Detective John Howe conducted another follow up visit with Mike to further advise him that his establishment was becoming a nuisance and that he needed to take control. Still, Mike wasn't able to bring order to the place and we continue to get complaints.

While I agree in part with Mr. Potere's email that there isn't any issues happening INSIDE of his establishment, that all of it is happening outside and he cannot directly control conduct outside his premises, I disagree that such conduct is unrelated. It is the patrons coming from inside going outside and creating the problems, loitering outside the establishment, being loud, and one of the things I suggested to Mike is to focus most of his security personnel outside moving people along and telling them they cannot loiter. Additionally, the noise isn't always from the people outside, many of the complaints are for the loud music coming from inside the establishment.

You will see included below in this email a list of calls for service at Gauchao since 5/1, after the shooting and after I spoke with Mike. There has been 18 calls for service there related to some type of disturbance. Compare that to 3 calls prior to the shooting since they took over management in the beginning of the year. Also compare it to the second list which includes calls for services at other establishments such as Five Horses, Michaels, Premiere, the Burren, and the Foundry. The most was Premiere with 4 and Gauchao has nearly 5 times the amount of calls. What is not included here is how often officers have to park in front of the establishment just for presence, waiting for either something to happen or for the crowd to clear out, time they could've been spending patrolling their sectors making sure the City is safe.

I believe this case warrants stronger action on the City's part. I would like to suggest at least a couple of things: rolling back their hours for the remainder of the summer until 12am, and ordering them to hire a police detail throughout the weekend. The police detail would be tasked with ensuring people are not loitering outside and it would serve as a way to show his private security what is expected of them as it relates to outside disturbances. Just because they relocate from inside to the sidewalk, it is still his patrons, still his problem, still his responsibility. Once they have completely left the area, then in my opinion he's excused but not if they are literally outside of his doors.

This is what I have to offer so far. I had been preparing something to present you at some point without urgency but the email exchanges between the councilor and some concerned residents should make this a priority. I can provide you a more detailed report with dates and times but it is essentially every weekend that we are called there. No other establishment currently is giving us such a problem. We need to take control this now before it gets out of control, before there is another shooting. Please let me know if you require anything further and if you wish to speak in person or via telephone on the issue.

DRAFT MINUTES

The meeting was called to order by Chair Joseph Lynch at 6:00 p.m. and adjourned at 7:02 p.m.

Communications

1. Minutes of the Regular Licensing Commission Meeting of 6/17/2025.

The Licensing Commission approved the minutes on a voice vote.

2. Communication from Commissioner Lynch, in his capacity as Chair, that the September 16, 2025, Licensing Commission meeting will be held via remote participation only.

The Licensing Commission placed this item on file.

3. Communication from Police Lieutenant Diogo DeOliveira regarding complaints received about H and P Restaurant Group LLC d/b/a Gauchao Brazilian Cuisine, 102 Broadway (AL24-000025).

Lieutenant DeOliveira explained to the Commission that since the ownership and operational management of this establishment changed in January 2025, the Police Department has received 62 calls to the licensee's address. These calls included one for an alleged shooting on April 27, 2025 involving patrons who left the establishment, as well as numerous others for noise disturbances and fights, all of which are happening late at night on Friday, Saturday, and Sunday nights.

Most recently, the Police issued two noise citations to the licensee during this past weekend, on Saturday, July 12 and Sunday, July 13. Lt. DeOliveira continued that patrol officers have also observed instances where around 100 people were lined up outside the establishment to attend events that were advertised on social media. Lt. DeOliveira noted for the record that, due to the high number of issues and calls related to this licensee's establishment, patrol officers have needed to park outside and simply wait for something to happen, which takes resources away from policing other parts of the city. Finally, Lt. DeOliveira stated that the licensee's neighbors have been complaining about noise from this establishment with more frequency, and that local political officials have become involved as well.

Chair Lynch asked Manager Potere to confirm the licensee's closing hours, who stated they are 1:00 a.m. Sunday through Thursday, and 2:00 a.m. on Friday and Saturday. Manager Potere further clarified that the 2:00 a.m. service license was carried over from the previous owner of the establishment, who had not received previous complaints regarding crowds or noise. Manager Potere also stated that they do not have an Entertainment by Patrons license, which is required to operate a dance floor. Chair Lynch asked for the name of the alcohol manager of record, and Manager Potere replied the manager on their license is Rony Figueroa.

Chair Lynch asked if their license contains conditions that require a security detail, and Manager Potere replied that their license was granted and issued without condition.

Chair Lynch asked for comments from the other Commissioners. Commissioner Allen stated for the record that if an applicant came before the Commission requesting a 2AM alcohol service license amendment and they had the same record as this licensee, that he would recommend rejecting the application, and that amending the hours and the entertainment licenses for this establishment might be appropriate here. Commissioner Thomas stated for the record that he would like to hear from the licensee before making a decision.

Chair Lynch stated that this number of calls and complaints for this establishment is much higher than with the city's other licensees, and recommended that the licensee appear for a Show Cause hearing, and that a Special Meeting should take place in

advance of the regularly scheduled Licensing Commission meeting to be held in August.

Chair Lynch moved to hold a Special Meeting of the Licensing Commission before the next regularly scheduled meeting on August 19, 2025. The Licensing Commission approved this motion on a voice vote.

Chair Lynch moved to call the licensee, H and P Restaurant Group LLC d/b/a Gauchao Brazilian Cuisine, 102 Broadway (AL24-000025), before the Commission during a Special Meeting to show cause as to why their All Forms Alcoholic Beverages 7 Day Restaurant License, 2AM Closing License, Common Victualer License, Entertainment by Devices and Performers License, and 10AM Sunday License should not be modified, suspended, revoked or forfeited, or the hours during which alcoholic beverages made be reduced for alleged violations of the Somerville Licensing Commission Rules and Regulations. The Licensing Commission approved this motion on a voice vote.

4. The Catered Affair, P.O. Box 432 Hingham, MA notifying the Commission of an Event for Berkshire Partners for approximately 175 Guests, to be held at 598 Assembly Row, on Wednesday, June 25, 2025, from 5:00 p.m. to 8:00 p.m. (Alcoholic Beverages served by The Catered Affair).

https://us02web.zoom.us/webinar/register/WN_ItCnZCpJQuq183M-IkUvUA on Tuesday, July 29, 2025 at 6:00 p.m. for you to show cause as to why your All Forms Alcoholic Beverages 7 Day Restaurant License, 2AM Closing License, Common Victualer License, Outdoor Public Seating License, 10AM Sunday Opening License, and Entertainment by Devices and Performers Licenses should not be modified, suspended, revoked or forfeited, or the hours during which alcoholic beverages be reduced, for alleged violations of the following Somerville Licensing Commission Rules and Regulations:

Somerville Licensing Commission Rule 1.09(a) -

It shall be the obligation of licensees to ensure that a high degree of supervision is exercised over the conduct of the licensed establishment at all times. Each licensee will be held accountable for all violations that are related to the licensed premises to determine whether or not the licensee acted properly in the given circumstances.

Somerville Licensing Commission Rule 1.09(e) -

When any noise, disturbance, misconduct, disorder, act or activity occurs in the licensed premises, or in the area in front of or adjacent to the licensed premises, or in any parking lot provided by the licensee for the use of its patrons, which in the judgment of the Commission adversely affects the protection, health, welfare, safety or repose of the residents of the area in which the licensed premises are located, or results in the licensed premises becoming the focal point for police attention, or is offensive to public decency, the licensee may be held in violation of the license and subject to proceedings for suspension, revocation or modification of the license.

The alleged violations include an alleged shooting that took place outside of the establishment on April 27, 2025, as well as approximately 62 calls to the Police Department regarding the licensed premises that occurred beginning in January 2025, 48 of which occurred between 11:00 p.m. and 2:00 a.m.
