AGENDA

1. Review of "Somerville Commission for Women Structure" document

- a. Melissa asked about operational definitions for the State Handbook-proposed committees (6 total). Angie clarified and provided examples while notes were taken live in the document by Katelin.
- b. Angie expressed a need for social media/communications being a priority. Outreach is key right now for the SCW. She will look into what social media the SCW has access to.
- c. Neeraj asked how we will learn about the issues and needs in our community. She wondered if the mayor would meet with us to inform us.
- d. Jenn noticed there is some overlap in what each committee will be responsible for.

- i. Angie confirmed there is flexibility on the names and goals of the subcommittees the SCW ultimately chooses.
- ii.Katelin echoed there will be flexibility and answered that there are no plans to meet with the mayor. However, we plan to learn about needs through friends, neighbors, and attending community events.
 - e. Jenn inquired about a way to track our community outreach activities
- i.Katelin said she had a spreadsheet to track this.
- f. Organization into sub-committees
- i. Bobby proposes collapsing the committee into three categories
 - 1. Ayerim agrees with Bobby. Ayerim agreed with members self-selecting into sub-committee groups.
- ii.Jenn inquired about how many hours each subcommittee should meet. Katelin said each commissioner must engage in ~5 hours per month. She said Commissioners should plan on dedicating one-hour per month.
 - g. Katelin proposes that each commissioner self-select into subcommittees.
- i.Commissioners self-select into subcommittees during the meeting. Groups were voted on and approved by members present.

2. Project Proposal (Jenn)

- a. Classes offered by people taught in our community. Jenn suggests working at the intersection of art. Inherent focus on interdisciplinary learning and connection. Examples include 'how to prune a tree;'
- b. Alex likes this idea and suggested outreach as a priority before moving forward with the idea so that we have a cohort of attendees. Angie clarified this idea is not foreign and very much possible.
- c. Nykia clarified the group has its feet in two places: long-term sustainability and short-term community engagement. The group nodded in agreement.

3. New Commissioner Orientation (Alex)

a. Alex offers a slide deck of a proposed onboarding document/slideshow, including Somerville community demographics, as well as languages spoken at home and income statistics. Alex invited members to add comments and thoughts to the document.
