The meeting was called to order at 6:50pm and adjourned at 7:19pm.

PUBLIC HEARING: Alterations to Local Historic District (LHD) Properties HP23-000058 – 15 Adams Street

(continued from 6 February 2024)

The applicant team explained the revised plan, showing the exterior existing conditions and proposed new conditions. New exterior window option A is proposed. All the windows on the second floor of that elevation are proposed to be razed and realigned with the original historic window. There is also a proposal to shorten two of the windows on the far left of the elevation on the second floor to accommodate for the kitchen counter. One window, under the third floor, is proposed to be added, centered, and aligned with the historic windows. The proposed window replacements are Marvin with simulated divided lights and a dark spacer bar between the interiors.

Chair Parkes opened public testimony. Seeing no public comment, Chair Parkes closed public testimony.

There was discussion by the Commission regarding option A. It was agreed that this proposal seems to make the windows look more harmonious.

Following a motion by Vice Chair Kelly, seconded by Member Coughlin, the Commission voted unanimously (4-0) to approve option A and all the conditions noted in the Staff Report.

RESULT: APPROVED

The Commission noted that, due to Commissioners needing to recuse themselves from the next two items, there would not be a quorum and the items would need to be continued to 19 March 2024.

PUBLIC HEARING: Alterations to Local Historic District (LHD) Properties
HP23-000051 – 57 Columbus Avenue

Following a motion by Member Chagnon, seconded by Vice Chair Kelly, the Commission voted unanimously (4-0) to continue 57 Columbus Avenue to 19 March 2024, due to lack of quorum.

RESULT: CONTINUED

PUBLIC HEARING: Alterations to Local Historic District (LHD) Properties HP23-000083 – 30 Bow Street

Following a motion by Vice Chair Kelly, seconded by Member Falvey, the Commission voted unanimously (4-0) to continue 30 Bow Street to 19 March 2024, due to lack of quorum.

PUBLIC HEARING: Determinations of Historic Significance (Step 1 in the Demolition Review Process) HP23-000054 – 326 Lowell Street

It was noted that the applicant was not present.

Following a motion by Vice Chair Kelly, seconded by Member Chagnon, the Commission voted unanimously (4-0) to continue 326 Lowell Street to 19 March 2024, as the applicant was not present.
