## PUBLIC HEARING: 483 Broadway (ZP23-000053) & 483 Broadway (ZP23-000054)

Member Daglian sat as a voting member for this item.

The Board opened both hearings for 483 Broadway (ZP23-000053 & ZP23-000054) simultaneously.

The applicant team explained that other variances will be sought for this project, leading to an extension needed for this item. The building has not changed in design, but additional details have been added to the plan.

Chair Fontano opened public testimony.

Lidia Rego Soares (10 Strathmore Road, Medford, MA) - asked about the additional variances being sought.

The applicant team explained that the original variance received was for building height requirements and number of stories. Extensions are being sought for these items. The building will remain a two-story building. There will be a Neighborhood Meeting held tomorrow night on this project.

Chair Fontano closed public testimony.

Following a motion by Clerk Garavaglia, seconded by Member Brockelman, the Board voted unanimously (5-0), in the matter of 483 Broadway (ZP23-000053) to approve the extension request for the previously issued Hardship Variance for the number of stories for six months, with all previous conditions and criteria set to apply.
