1.	Can you please send me a copy of the current bid on file?  Is last year's winning bid available to the public? 2.	Could you provide any more context as to why this went out to bid? Was the current vendor's contract up?	The City is going out to bid in order to consolidate two separate contracts into one joint contract (IFB 24-57 <i>Portable Restrooms for DPW</i> and IFB 23-50 <i>Portable Restrooms for the City, Seasonal Locations</i> ).
3.	This is my first time including a cover letter, and I would appreciate some clarification. Specifically, could you advise on what information is required regarding an official authorizer who can contractually bind the offer?	The official authorizer should be the individual given authority to sign via the Certificate of Signature Authority (form can be found on page 24 of the IFB package).
4.	Since it's optional, am I still adding the price for the Hand Washing Station to page 17 under "Bid Grand Total"?	Pricing for Section 3: Hand Washing Stations should <u>not</u> be included in your Bid Grand Total, since it is optional.
5.	There is an error on the "Est. Contract Completion Date" on the first page of the IFB package. I believe this date should be 3/14/ <b>2027</b> , not 2026.	The Est. 
