**Focus: Engineering Review (40 minutes)**

- Western Pearl Street Reconstruction project – Unanimous comments from the committee:

Appreciate that this largely implements “Option 1” plus improvements to the connection through Ed Leathers Park

Would prefer if the Ed Leathers routing had less elevation change and less zig-zagging, but appreciate constraints

Recommend clear wayfinding, especially around Skilton Ave, given circuitous routing  
Preference for bus stops similar to Concord Ave / Vasser Ave where bus loads from the cycle track, especially since the 80 is planned to be removed

- Broadway Magoun Reconstruction project – unanimous comments from the committee:  
Appreciate that protected bike lanes are included in both directions. Emphasize that protected bike lanes should continue all the way through Magoun, and narrowing the intersection width to minimize turning conflicts  
Supportive of extending bus lane further west  
Emphasize that with a school potentially located at Trum Field, it will be important to have high standard for safe bike lanes and pedestrian crossings

- Letter to Traffic Commission – Vote to bring up community process in letter and bring suggestion to have larger street changes to time that works for all members of traffic commission. Motioned by Alex, Seconded by Amanda.
