3. New Business

➤ Department of Mobility: Rishika Dhawan and Luis Quizhpe

- The Department of Mobility presented as a focus group to solicit feedback on how they can hear from seniors, how they can gather more information about their needs, and how they can spread the word about upcoming projects. They have used feedback from seniors to make such changes as the bike lanes by Clarendon Hill and traffic routes by Pearl St. Park.
- Board provided feedback that, in general, they are not aware of projects on side streets/parking changes until the work occurs, and a sense that community feedback is not incorporated into the plans. Suggestions included: more aggressive advertising and engagement, the plan for Somerville's streets should be updated, more education about bike/scooter safety, increased enforcement regarding bikes, suggestion of signs sharing information about the projects be posted at the work sites.
- Conversation also focused on ways to incorporate feedback once the project has been completed and providing information on intersections that are still considered dangerous.

The focus of the conversation was on the McGrath Highway restructuring and the proposal which does not include a pedestrian footbridge. Group shared there is a public meeting and they are still taking public comments. Group spoke about the Senior Taxi Program expansion and feedback was shared about other programs such as The Ride and Door 2 Door. Group also discussed the snow shoveling program and concerns with plowing bus stops, sidewalks and cross-walk entrances when it snows
