 - 1. In support of East Somerville Main Streets promote Eat Out in East to support East Somerville
 - 2. In support of proposed House Bill, the PROTECT Act, an Act promoting rule of law, oversight, trust, and equal constitutional treatment.
 - 3. In support of House Bill H.1588 and Senate Bill S.1122, an Act relative to immigration detention and collaboration agreements.
 - 4. That the Director of Racial and Social Justice provide an update to this Commission on the status of the Police Civilian Oversight Committee.
 - 5. That the Chief of Police provide this Commission with data on pedestrian and bicyclist enforcement activities in the city.
 - 6. That the Chief of Police annually review pedestrian and bicyclist enforcement data to identify disparities in enforcement patterns across demographic or neighborhood lines and submit this data to this Commission.
 - 7. Supporting the fourth amendment rights provided in the Constitution of the United States.
 - 8. That this Commission commends the students at Somerville High School for their action and resolve in protesting Immigration and Customs Enforcement (ICE) deportations in Somerville and across the nation.
 - 9. That this Commission supports Somerville Stands Together initiative to Revitalize the Wage Theft Commission and will sponsor and plan a workshop on wage theft with Attorney General's Office in late March.
 - 10. That this Commission recognize the holy month of Ramadan and dedicate our work to protecting residents rights to free exercise of religion including freedom from Islamophobia.
 - 11. That this Commission address institutionalized Islamophobia in sponsoring a workshop and/or planning a workshop.
