**Communications**

1. Minutes of the Licensing Commission Regular Meeting of 3/17/26.

**The Licensing Commission accepted the minutes on a voice vote.**

2. Licensing Commission requesting a status report from Somerville City Club Inc., d/b/a Somerville City Club, 20 Inner Belt Road, AL17-000025, regarding the use of their All Forms Alcohol Service License.  
*Continued from October 21, 2025, and February 17, 2026, Licensing Commission meetings.*

**Donald Johnson, the applicant, appeared before the Commission and stated that, due to some legal issues with their current location, they are looking to keep their alcohol license and move it to a smaller location within the city.**



**The Licensing Commission continued this item to the August 2026 meeting by unanimous consent.**

3. Communication from Commissioner Lynch, in his capacity as Chair, regarding the option for licensees to extend their operating hours during the upcoming World Cup event, from June 11, 2026 through July 19, 2026.

**Chair Lynch stated that the goal with this initiative is to allow Somerville restaurants to easily extend their hours to accommodate the showing of World Cup soccer matches to stimulate business, and that the hours permitted for alcohol service would be from 9:00 a.m. until 2:00 a.m., and a closing time of no later than 3:00 a.m. Commissioner Thomas asked if this would apply to other types of businesses, and Chair Lynch replied it would just be for restaurants with alcohol service. Captain DeOliveira stated that the Police Chief has some concerns with the proposal and how it might impact department staffing, and noted that a single incidence of someone driving under the influence can require as many as three officers. Captain DeOliveira recommended having additional police during days where games would be played later in the night. Chair Lynch noted that additional staffing would depend on how many establishments opt-in to the program, which Captain DeOliveira confirmed. Assistant City Clerk Potere noted that a list of businesses who opt-in to this program will be shared with the Police Department; Lieutenant Otting requested that Fire Prevention also receive a copy of this list, which Assistant City Clerk Potere confirmed.**

**Chair Lynch stated that, when a business extends their hours under this program, it is essential that all permit holders remain mindful of local regulations and community impact. Chair Lynch continued that restaurants should ensure that noise is kept to a minimum, and that they are addressing any other compliance issues to avoid potential penalties or the revocation of their permits. Lastly, Chair Lynch stated that any Excessive noise, over-serving patrons, underage alcohol consumption, or loitering outside the establishment could result in the immediate revocation of the extended permit hours.**

**Chair Lynch stated that there will be no fee for restaurants to participate in this extended hours program.**

**The Licensing Commission approved this extended operating hours program during the upcoming World Cup on a voice vote.**

Chair Lynch asked about the location of the structure, and the applicant replied it would be across the street from their storefront, and that they would encourage staff and patrons to utilize the crosswalk. Chair Lynch asked who would be serving the alcohol, and the applicant replied that it will be staff from their restaurant. Chair Lynch asked how power would be provided, and the applicant replied via a generator, to which Chair Lynch recommended that the applicant have that reviewed by Fire Prevention. Commissioner Thomas asked if this will occupy an accessible parking space, and the applicant stated it would not.**

**The Licensing Commission approved this Special Alcohol License on a voice vote.**

**Attorney Anne Vigorito appeared behalf of the licensee, Rony Figueroa, and Ashley Herrera, one of the establishment's shift managers, and explained that they have learned a lot in the time since the noise complaints first arose in July 2025, and that they have made significant efforts to reduce impact to the surrounding**



neighborhood, including by hiring a person to monitor sound levels and mixing. Attorney Vigorito continued that the licensee has also hired security for weekend nights, typically hiring three or four guards, and that they are no longer hiring DJs to perform to reduce the impact of large crowds. Chair Lynch asked the licensee if they have been keeping a log of incidents as requested during their show cause hearing in July 2025, and the licensee replied that they have but that they did not bring it with them to this meeting. Captain DeOliveira stated that this licensee has shown improvement, reducing the number of noise complaints from 62 in 2025 to only 10 in 2026. Captain DeOliveira added that what happens outside of their establishment is their responsibility, as patrons leave the restaurant intoxicated and can cause disturbances in the public space beyond the restaurant itself.

Chair Lynch opened the public hearing. J. Santana stated they are an abutter to this business and that they have never heard any noise and expressed support for the licensee's 2AM license. There being no additional speakers, Chair Lynch closed the public hearing.

Chair Lynch moved to approve a 2AM license for 60-days, and to have the licensee come back for the June 2026 meeting to revisit the item. The Licensing Commission approved this 2AM License with an expiration of June 21, 2026 on a voice vote.
