Approval of Previous Minutes

The subcommittee reviewed the May 18, 2026, Administration Subcommittee Meeting Minutes. **A motion was made to approve the minutes, seconded by Salma Kazmi, and approved unanimously.**

1.Unfinished Business

Human Rights Commission Bylaws

The subcommittee continued its review and development of the draft Human Rights Commission bylaws. Members discussed revisions intended to improve clarity, organization, and implementation. Additional revisions will be needed before the draft is presented to the full Commission for consideration

Human Rights Advisory Council

The subcommittee continued developing the proposed Human Rights Advisory Council. Discussion focused on refining the purpose and framework of the Council, preparing a working draft before seeking broader Commission input, and creating a structured process for commissioners to provide feedback. Members discussed using a Google Form or questionnaire to collect written comments and recommendations. The subcommittee agreed that drafting and refinement should continue within the Administration Subcommittee before the proposal is returned to the full Human Rights Commission.

2,New Business

Discussion of Public Comment Procedures and Open Meeting Access for Human Rights Commission and Subcommittee Meetings

The subcommittee discussed public comment procedures and opportunities to improve public access and participation during Human Rights Commission and subcommittee meetings. Members considered the importance of having clear and consistent processes for receiving community input and ensuring meetings remain accessible and transparent. The discussion will continue as the Commission considers potential procedures and practices for future meetings

- Continue revising the draft Human Rights Commission bylaws.
- Continue developing the Human Rights Advisory Council proposal.
- Develop a Google Form or similar questionnaire for commissioner feedback.
- Present future revisions of the Advisory Council proposal to the full

Human Rights Commission following additional Administration Subcommittee review.
