REPORT OF THE COMMITTEE ON LAND USE

The Committee on Land Use held a meeting on October 2, 2008, with Chairman Sean O'Donovan presiding and Committee Member Alderman Maryann Heuston also present and voting. Also present were Monica Lamboy and Madeleine Masters from SPCD.

Ms. Masters addressed the committee regarding the proposed Winter Hill Commercial District moratorium and stated that the underlying zoning is frozen for 6 months and may be reviewed after that period of time. The zoning restricts the owner of the former Star Market site from developing the property. Ms. Lamboy informed the members that there is a major upscale for the developer of the property and that the developer is being urged to work with the city. Ms. Lamboy also stated that further study is needed to determine what the best development option would be for the area.
