Item #6 – Request from the BOA to consider revising the rules for the renewal of residential parking permits and consider fee proration for periods less than a full year (tabled from Oct and Nov 2017)

Item #7 – Request for 2 Hour Parking Except by Permit 8am-2:30am, Permit Parking Only 2:30am-8am

- a) Boston St, at Washington St, first 4 spaces on the west side and first 2 spaces on the east side
- b) Mansfield St, at Washington St, first 2 spaces on the west side
- c) Rossmore St, at Washington St, first space on the east side and first 2 spaces on the west side
- d) Merriam St, at Washington St, first 2 spaces on the west side

Item #8 – Request for the following changes to parking on Highland Av around City Hall/ High School

- a) Highland Av, north side, first five spaces beginning just east of the concourse entrance. Change the existing restriction for 2 Hour Parking Except by Permit 8am to 2:30am; Permit Parking Only 2:30am to 8am to: Monday-Friday Pick-up/Drop-off 7am-9am and 2pm-5pm; 2 Hour Parking Except by Permit 9am-2pm and 5pm-2:30am; Resident Permit Parking Only 2:30am-7am; and Saturdays 2 Hour Parking Except by Permit 7am-2:30am; Resident Permit Parking Only 2:30am-7am
- b) Highland Av, north side, two spaces between the west side of the City Hall/High School Concourse entrance and the bus stop adjacent to School St. Change the existing restriction for 2 Hour Parking Except by Permit 7am-2:30am; Permit Parking Only 2:30am-7am to: Monday-Friday Pick up/Drop Off 7am-5pm; 2 Hour Parking Except by Permit 5pm-2:30am; Resident Permit Parking Only 2:30am-7am; and Saturdays 2 Hour Parking Except by Permit 7am-2:30am; Resident Permit Parking Only 2:30am-7am

Item #9 – Request that the Safety Zone on College Av and Elm St between Talbot Av and Grove St be separated into the following three safety zones:

- College Av between Talbot Av and Broadway
- College Av between Broadway and Highland Av
- Elm St between Highland Av and Grove St
