- a) 7 Gilman Terrace
- b) 10 Tyler St (2 spaces)

Item #3 – Request for two loading zones 71-72 Union Square

- a) Existing 15 minute meter, replace with 20 minute commercial/ 5 minute passenger loading zone from 8am-5pm, revert back to metered parking 5pm-8pm
- b) Existing pay to park space: replace with 20 minute commercial/ 5 minute passenger loading zone from 8am-5pm, revert back to pay to park 5pm-8pm

Item #4 – Request to extend the fire lane at 6-8 Lincoln Parkway on the south side of the street 40 ft. west

Item #5 - Request to making the following curb regulation changes as part of the upcoming Powder House Circle Safety Improvements Project:

- a) Shift the eastbound bus stop on Broadway opp Warner St east by approximately 210 ft and extend the total length of the stop to 120 ft, requiring the restriction of the 5 on-street parking spaces nearest to the intersection at this location.
- b) Shift the westbound bus stop on Broadway at Warner St east by approximately 60 ft and extend the total length of the stop to 95 ft, requiring the restriction of the 4 on-street parking spaces nearest to the intersection at this location.
- c) Shift the northbound bus stop on College Ave at Warner St north by approximately 140 ft and extend the total length of the stop to 120 ft, requiring the restriction of the 3 on-street parking spaces nearest to the intersection at this location.
- d) Shift the southbound bus stop on College Ave at Powder House Sq north by approximately 20 ft and extend the total length of the stop to 120 ft, requiring the restriction of the 5 on-street parking spaces nearest to the intersection at this location.
- e) Restrict the 2 on-street parking spaces nearest to the intersection on the west side of Powder House Blvd

- f) Extend the total length of the westbound bus stop on Broadway at Walker St to 120 ft and restrict the 5 on-street parking spaces nearest to the intersection at this location.
- g) Remove the eastbound bus stop on Broadway at College Ave and replace the stop with a no parking any time regulation.
- h) Shift the southbound bus stop on College Ave at Broadway south by approximately 20 ft and extend the total length of the bus stop on College Ave at Broadway to 125 ft, requiring the restriction of the 3 on-street parking spaces nearest to the intersection at this location.
- i) Shift the northbound bus stop on College Ave at Broadway south by approximately 210 ft and extend the total length of the stop to 120 ft, requiring the restriction of the 8 on-street parking spaces nearest to the intersection at this location.
