PLANNING BOARD MINUTES

A **joint public hearing** for all interested parties was held by the **Planning Board** and the **Board of Aldermen Land Use Committee** on **Wednesday, November 15, 2017 at 7:30 p.m.** in the **Aldermanic Chambers on the Second Floor of Somerville City Hall, 93 Highland Avenue, Somerville, MA.** The purpose of the hearing was to receive public comments concerning the following:

AN AMENDMENT TO SECTION 7.15, TITLED MEDICAL MARIJUANA FACILITIES, OF THE SOMERVILLE ZONING ORDINANCE, EXTENDING THE TEMPORARY ORDINANCE UNTIL JUNE 30, 2019.

Extension of Section 7.15 SZO until June 30, 2019.

Rossetti said recreational marijuana is permitted by the state to be discussed within the municipalities now in preparation for April 2018 start date.

Capuano said this is a temporary ordinance, so how does impact the 2 businesses already in operation if the zoning is overhauled/change? Businesses can continue as usual. Zoning amendment will be presented to BoA – moratorium during study period.
