PROJECT UPDATES

HPC Guidelines Revisions (Abby Freedman with Amie Schaeffer)

- Committee met on Wednesday, 6/13/12 from 7-9pm.
- Update on progress.
- Next meeting on Wednesday, 7/11/12, from 7-9pm.

Milk Row Cemetery Preservation Master Plan Implementation (Brandon Wilson)

- Recent enhancements at the Cemetery include 3 benches in the interior and 1 bench at the bus stop
- Grant application to MHC still pending their review; final announcements to be made in mid-June.
- Tour of the Cemetery on May 17th was very well attended with 26 members of the public, including Commissioners George Born and Alan Bingham, former Commissioners Kevin Jackson and Christine Young, and new Director of Veteran's Affairs, Jay Weaver, whom we hope to work with in the future to better honor the buried veterans. Presentations were given by Historic Somerville Board members Barbara Mangum and Lawrence Wilwerth, and by Brandon Wilson. The videotaped event is currently showing on cable tv.
- Next step is to initiate a trial Docent Program to open the Cemetery to the public more often, initially once a month during the warmer weather. Two possible docents attended the tour.

West Branch Library (WBL) Improvements (Brandon Wilson)

• Mayor has reviewed the consultant's (TBA Architects, Inc.) preliminary findings for the accessibility study and indicated at recent Ward 6 Resistat meeting that would like to proceed with new accessible bathroom and entry as part of a much larger renovation of both branch libraries. While full building assessment at the WBL is planned soon, Mayor will be seeking funding for the implementation work in the FY2014 Capital Budget.

Assembly Row Historic Enhancement Project (Brandon Wilson & Kristi Chase)

• Work continues providing historic information and photos to Federal Realty Investment Trust (FRIT) development team for their marketing and website.

Preservation Awards Program (Brandon Wilson, Derick Snare, and Amie Schaeffer)

 Awards Ceremony held on May 31st, this year at the Somerville Armory. Very well-attended with over 65 people, including Superintendent Tony Pierantozzi, George Proakis & Michael Glavin

from OSPCD, (7) Commissioners, most winning SHS students, and (4) SHS teachers. All of the winning property owners came, often with family and neighbors, and in some cases with their contractors and architects. All shared their project experiences and lessons, met their student artists, and received certificates from the SHPC and the Mass. State Legislature through Senator Jehlen's Office. Dick Bauer and Abby Freedman presided over the ppt presentation. Mayor attended following several other commitments that night and spoke about the value of the Program to the City. All of the food was donated by local businesses--Mamma Lisa's Pizzeria, Peasant Stock Catering, Redbones Barbecue, and the Somerville Theatre, and the wine and other accompaniments by Commissioner Thom DeYoung. Many thanks to the set-up Committee – Ryan Falvey, Abby Freedman, Eric Parkes, and Tom DeYoung, and to the SHS teachers , Kristi Chase, and Derick Snare for working with the property owners and the SHS students and making this Awards Ceremony both possible and so successful. Stanhope Framers of Union Square and Century Bank contributed invaluable labor and financial support for the professional framing and presentation of all of the SHS students' artwork.

- The 2012 Exhibit of the Preservation and Director Awards and accompanying photos and student drawings are on display at City Hall, 2nd floor for the summer months. It will move to other local venues for the rest of the year (site ideas welcome!). The 2011 Exhibit is still viewable at the Century Bank on Fellsway West, but will be ending soon so the property owners can finally receive the artwork for their own walls.
- Marian Berkowitz expects to complete her interviewing and photos of the 2012 owners shortly. Brandon will edit and embellish them for submission to the local media for expected publication over the summer months.

- Walking Tour "From Mansions to Mudflats: East Somerville's Cornucopia of Cultural Treasures" (Sun. May 6th, 3:30-5:30pm) by Edward Gordon, in collaboration with East Somerville Main Streets (ESMS).
 - Excellent turnout, new area north of Broadway explored; including interior tour of recently renovated Mudflats Studios; reception at conclusion on Broadway with Tapatio donating very generous refreshments; 29 people.
 - o Self-guided tour brochure prepared and posted on SHPC's website.
 - Photos to be posted on both ESMS (<u>www.eastsomerville.org</u>)and SHPC websites.
- Jane's Walk of Magoun Square Area (Sat. May 5^{th,} 10am 12:30pm). Began at Hanson Park. 13 people.
 - Ideal-sized group of neighbors explored wide area, with interior tours of 2 Somerville Open Studios. Discussion focused on recent enhancements to area, in progress projects such as Maxwell Green Development, Green Line Transit and Community Path Extensions, and 'Urban Village' character of some areas, which eligible for expanded local historic districting;
 - Event videotaped and being shown on City cable station.
- Talk: "The Menace of the Three Decker" (Sun. May 13th/Mother's Day, 2pm at Somerville Museum) by Stuart Brorson. Sponsored by Historic Somerville, in collaboration with the SHPC. Over 25 people. Many questions and refreshments at the end. Free for Mothers and HS members; \$8 for others.

- Historic Bike Tour of "Somerville Parks, Then and Now" (Sun. May 20th, 2-4:30pm). 11th annual event in collaboration with Somerville Bike Committee. Donation of \$3 appreciated. Leaders included Commissioners Dick Bauer and DJ Chagnon, Brandon Wilson, Ron Newman, and Arn Franzen, OSPCD Director of Parks & Open Space . 71 people.
